The East 6.0 Acres of that part of the North 1/2 of the North West 1/4 of Section 12, Township 38 North, Range 12, the East 200 Feet Thereof and North of the Northwestern Line of the 26 Foot Right-of-way of the Chicago and Illinois Western Railroad.

ALSO
