That at the special instance and request of said contractor the claimant furnished extra and additional labor and/or materials on said premises of the value of **\$0.00**. That said contractor is entitled to credits of account thereof as follows: **\$0.00**, leaving due unpaid and owing to the claimant, after allowing all credits, the sum of **Three Thousand Eight Hundred Ninety Six Dollars and 90/100ths (\$3,896.90)** dollars, for which, with interest, the claimant claims a lien on said land and improvements, and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.

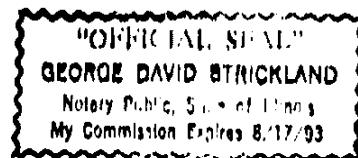
