- 1) That water service was furnished to herein described property by the Claimant, at the rate as provided by Chapter 185 of the Municipal Code of the City of Chicago.
- 2) That the quantity of water was approximately 92 thousand cubic feet.
- 3) That the amount due for water service is \$632.79.
- 4) That sewer service was furnished to the herein described property by the Claimant, at the rate as provided by Chapter 185.1 of the Municipal Code of the City of Chicago.
- 5) That the amount due for sewer service is \$493.57.
- 6) That the total amount due the Claimant therefore is \$1,126.36.
- 7) That the above amounts became delinquent on 1-14-91.
- 8) That notice of the filing of this claim for lien was mailed to "owner or owners and party or parties interested in the premises" located at 4351 N. 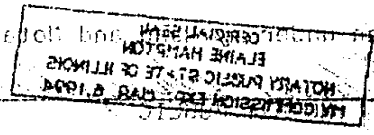
