and other good and valuable considerations in hand paid, does thereby convey and quit claim unto said party of the second part, the following described real estate, situated in Cook County, Illinois, to wit:

LOT "A" IN MZIK RESUBDIVISION OF LOT 1337 (EXCEPT THE EASTERNLY 1/3 THEREOF AS MEASURED BY THE STREET AND REAR LINES THEREOF) IN BLOCK 36 IN THIRD DIVISION OF RIVERSIDE OF SECTION 25, TOWNSHIP 39 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO PLAT THEREOF RECORDED SEPTEMBER 26, 1960 AS DOCUMENT 17973529 AND CERTIFICATE OF CORRECTION RECORDED SEPTEMBER 15, 1961 AS DOCUMENT 18276107, IN COOK COUNTY, ILLINOIS.




