That on September 19, 1990, the owner owned the described land located at 6720 S. East End, in the County of Cook, City of Chicago, States of Illinois, and more particularly described as follows:

Lots 36 and 37, in Block 3 in South Jackson Park Subdivision of the Northwest 1/4 of the Southwest 1/4 of Section 24, Township 38 North, Range 14, East of the Third Principal Meridian, in Cook County, Illinois

and Preppers, Inc. was the owner's contractor for the improvement thereof.

That on September 19, 1990, said contractor made a subcontract with the claimant to furnish materials, being paint and paint related supplies, for the improvement of the above

described property, and that on February 11, 1991, the claimant completed the contract thereunder by delivering the materials to the above described property and the value of the materials is Three Thousand Two Hundred Eighty-One Dollars and Eight Cents (\$3,281.08).

That said contractor is not entitled to any credits on this account, and there is now due, unpaid, and owing to the claimant, after allowing all just credits, the sum of Three Thousand Two Hundred Eighty One Dollars and Eight Cents (\$3,281.08) with interest, for which the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.

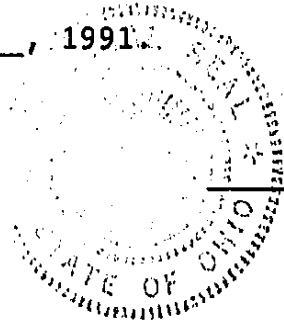
