# Excerpts From Internal Revenue Code

#### Sec. 6321, Lien For Taxes

if any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest additional amount, addition to tax, or assessable penalty together with any coats that may accrue in addition theretog shall be a lien in favor of the United Blates upon all property and rights to property, whether real of personal, belonging to such person

#### Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the ten Imposed by section 8321 shall arise at the time the assess-ment is made and shall pontinue until the liability for the amount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied at becomes unenforceable by reason of lapse of time.

#### Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors. - The tien imposed by section 8321 shall not be valid as against any purchaser, holder of a security interest, mechanic's fierior, or suggest ment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary
