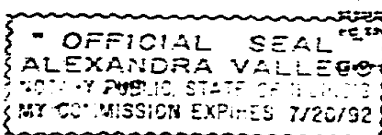

does hereby covenant and agree with the said Countywide Funding Corp.


That the said Countywide Funding Corp. shall be and remain at all times a second lien upon the premises
