ASSIGNMENT OF RENTS AND SECURITY AGREEMENT

MORTGAGE

This Mortgage, Assignment of Rents and Security Agreement is made this 4th day of February, 1991, between Circle Christian Development Corporation (hereinafter referred to as "Mortgagor"), and the City Of CHICAGO, DEPARTMENT OF HOUSING, together with its successors and assigns, having its principal office 318 South Michigan Ave., Chicago, Illinois 60604 (herinafter referred to as "Mortgagee").

WHEREAS, Morigagor has concurrently herewith executed and delivered a Note bearing even date herewith in a principal sum not exceeding Twenty Four Thousand Four Hundred Fifty Dollars (\$24,450.00), made payable to the Mortgagee, in which the Mortgagor promises to pay the said principal sum, plus interest thereon, at the rate specified in said lete on or before May 1, 1998. All of said principal and interest payments shall be made payable to the Mortgagee and delivered to the Mortgagee at the office of Mortgagee or Mortgagee's designated agent, in Chicago, Illinois or at such other place as the Mortgagee, or Mortgagee's designated agent, may declare in writing; and

WHEREAS, the Mortgagee is desirous of securing the payment of the Note, together with interest thereon, in accordance with the terms of the Note, and any additional indebtedness or obligations incurred by the Mortgagor on account of any future payments, advances or expenditures made by the Mortgagee pursuant to the Note or this Mortgage or the Construction Loan Agreement (as hereinafter defined); and, provided that any future payments, advances or the Construction Loan Agreement shall be secured by an additional mortgage or an amendment to this Mortgage;

ARTICLE I.

NOW, THEREFORE, in order to secure the payment of the principal and interest under the Note and the performance of the covenants and agreements contained in this Mortgage, including any extensions or modifications hereto, Mortgagor does by these presents (as hereinafter defined grant, bargain, sell, convey and mortgage) unto Mortgagee, its successors and assigns forever and hereby represents and warrants to Mortgagee and grants to Mortgagee and its

- 3. Any interest, escates or other claims or every name, kind or nature, both in law and in equity, which MORtgagor now has or may acquire in the Real Estate and Improvements, now owned or hereafter acquired;
- 4. All of Mortgagor's interest and rights as lessor in and to all leases, subleases and agreements, written or oral, now or hereafter affecting the Real Estate or the Improvements, or any part thereof, and all income, rents, issues, proceeds and profits accruing and to accrue from the Real Estate and Improvements;
- 5. All right, title and interest of the Mortgagor in and to all fixtures, personal property of any kind or character now or hereafter owned by Mortgagor and attached to or contained in and used or useful in connection with the Real Estate and Improvements;
- 6. All the estate, interest, right, title or other claim or demand which Mortgagor now has or may hereafter have or acquire with respect to (a) proceeds or insurance in effect with respect to the Real Estate and Improvements, and (b) any and all awards, claims for decages, judgments, settlements and other compensation made for or consequent upon the taking by condemnation, eminent domain or any like proceeding of the whole or any part of the Real Estate and Improvements; and
- 7. All other property rights of the Mortgagor of any kind or character related to the Real Estate and Improvements.

IT IS FURTHER agreed, intended and declared that all the aforesaid property rights and interests shall, so far as permitted by law, be deemed to form a part and parcel of the Real Estate and Improvements, this Mortgage is hereby deemed to be and is, as well, a Security Agreement under the Illinois Uniform Commercial Code for the purpose of creating a security interest in such property, which Mortgagor hereby grants to the Mortgagee as secured party (as defined in the Illinois Uniform Commercial Code).

TO HAVE AND TO HOLD the Premises unto the Mortgagee and its successors and assigns, forever, for the purposes and uses herein set forth.

ARTICLE II, GENERAL ACREIMENTS

To protect the security of this Mortgage, the Mortgagor further covenant and agrees as collows:

- 1. Payment of Principal and Interest. Mortgage shall pay promptly when due the principal and interest and any other sums required to be paid on the Note or under this Mortgage or the Construction Loan Agreement at the time: prof. in the manner provided therein and shall pay any other indebtedness secured hereby as same becomes due, and shall duly perform and observe all of the covenants, agreements and provisions contained herein and in the Construction Loan Agreement.
- 2. Preservation, Restoration and Use of Premises. The Mortgagor shall:
 - promptly repair, restore, replace or rebuild any portion of the Premises which may become damaged, destoryed, altered, removed, served or demolished, whether or not proceeds or insurance are available or sufficient for the purpose, with replacement at least equal in quality and condition as existed prior thereto, free from any security interest in incumbrances on or reservation of title thereto;
 - (b) keep and maintain the Premises in good condition and repair, without waste, and free from mechanics' liens, materialmen's liens or like liens or claims or other liens or claims for lien of whatever nature:
 - (c) complete, within a reasonable time, any Improvements now or hereafter in the process of erection upon the Premis(s)
 - (d) comply with all statutes, rules, regulations, orders or decrees and other requirements of any governmental body, federal, state or local, having jurisdiction over the Premises and the use thereof and observe and comply with any conditions and requirements necessary to preserve and extend any and all rights, license, permits (including without limitation zoing variances, special exceptions and non-conforming uses), privileges, franchises and concessions that are applicable to the Premises or its use and occupancy;
 - (e) make no material alterations in the Premises, except as required by law or municipal ordinance;

- (f) suffer or permit no change in the general nature of the occupancy or use of the Premises without the Mortgagee's prior written consent;
- (g) pay when due all operating costs of the Premises;
- (h) initiate or acquiesce in no zoing reclassification with respect to the Premises, without the Mortgagee's prior written consent;
- (i) not abandon the Premises, nor do anything whatsoever to depreciate or impair the value of the premises or the security of this Mortgage;
- refrain from any action and correct any condition which would increase the risk of fire or other hazard to the Premises or any portion thereof;
- (k) cause the Premises to be managed in a competent and professional manner;
- (1) not permit execution of any leases for a term in excess of one (1) year without the prior written consent of there Mortgagee;
- (m) not permit any unlawful use or nuisance to exist upon the Premises; and
- (n) provide the Mortgagee or its authorized representative with access to the Premises, subject to the rights of the tenants, at all reasonable times for the purpose of inspecting the Premises.
- 3. Payment of Taxes and Other Charges. Moragagor shall be responsible for the payment, when first due and owing and before any penalty attaches, of all taxes and assessments (general or special), water charges, sewer charges, and any other charges, see, taxes, claims, levies, expenses, liens and assessments, ordinary or extraordinary, governmental or non-governmental, statutory or otherwise, that may be asserted against the Premises or any part thereof or interest therein. Mortgagor shall promptly furnish to Mortgager duplicate receipts evidencing payment thereof. Notwithstanding anything contained herein to the contrary, Mortgagor may, in good faith and with reasonable diligence, contest the validity or amount of any such taxes or charges, provided that any such contest stops the enforcement of such taxes, assessment, or charges.
- 4. Insurance. The Mortgagor shall insure and keep insured the Premises and each and every part and parcel thereof against such perils and hazards' as the Mortgagee may from time to time require, including, without limitation:

- (a) Insurance against loss to the Improvements caused by fire, lightning, windstorms, vandalism, malicious mishchief, and risks covered by the so-called "all perils" endorsement and such other risks as the Mortgagee may reasonably require, in amounts equal to the full replacement value of the Improvements, and naming the Mortgagee as an additional and named insured thereunder;
- (b) comprehensive general public liability insurance against bodily injury and property damage in any way arising in connection with the Premises naming Mortgagee as an additional named insured party thereunder;
- During the making of any alterations or improvements to the Premises insurance covering claims based on the owner's or employer's contingent liability not covered by the insurance provided in subsection (b) above and workmen's compensation insurance covering all persons engaged in making such alterations or improvements.

All poricles of insurance to be maintained and provided as required herein shall be in forms, with companies and in amounts reasonably satisfactory to Mortgagee, and all policies of casualty insurance shall have attached thereto waiver of subrogation and mortgagee loss payable clauses or endorsements to favor of and with loss payable to Mortgagee.

All said insurance shall provide for thrity (30) days prior written notice of termination or cancellation to Mortgagee. Mortgagor shall deliver all policies, or certificates thereof, including additional and renewal policies, to Mortgagee marked "paid," and, in case of insurance policies about to expire, the Mortgagor shall deliver renewal policies or certificates thereof, not less than thirty (30) days prior to the respective dates of expiration.

- 5. Proceeds of Insurance. In the event of any damage to, or destruction of, the Premises, the Mortgagor will promptly give written notice to the Mortgagee of such damage or destruction.
 - (a) In case of loss covered by policies of insurance, the tortgagee (or, after entry of decree of foreclosure, the purchaser at the foreclosure sale or decree, as the case may be) is hereby authorized at its option either;
 - (i) to settle and adjust any claim under such policies without the consent of the Mortgagor; or

- (ii) to allow the Mortgagor to agree with the insurance company or companies on the amount to be paid upon the loss. The Mortgager shall, and is hereby authorized to, collect any such insurance proceeds and the expenses incurred by the Mortgagee in the adjustment and collection of insurance proceeds shall be deemed additional indebtedness secured by this Mortgagee and shall be reimbursed to the Mortgagee upon demand.
- (b) In the event of any insured damage to, or destruction of, the Premises or any part thereof Mortgagee may, in its sole discretion;
 - (ii) apply the proceeds of insurance payable upon the indebtedness secured hereby in such order or manner as the Mortgagee may elect; or
 - (i(i) apply the proceeds of insurance to reimburse the Mortgagtor for the cost of restoring, repairing, remacing or rebuilding the Premises or any part thereof.
- In the event proceeds of insurance, if any, shall be made available to the Mortgagor for the restoring, repairing, replacing or resultding of the Premises, the Mortgagor hereby covenants to restore, repair, replace or rebuild the same, to be of at least equal value, and of substantially the same character as prior to such damage or destruction, all to be effected in accordance with plans and specifications to be first submitted to and approved by the Mortgagee.
- 6. Condemation and Eminent Domain. The Mortgagor shall give Mortgagee prompt notice of any proceedings, instituted or threatened, seeking condemnation or taking by eminent domain or any like process (generally "Taking"), of all or any part of the Premises or affecting any easement thereon or appurtenance thereof and shall deliver to Mortgagee copies of any and all papers served in connection with any such proceedings, and Mortgagor hereby assigns, transfers and sets over unto Mortgagee the entire proceeds of any and all awards resulting from any Taking. Mortgagee is hereby authorized to collect and receive from the condemnation authorities said awards and is further authorized to give appropriate receipts therefor.
- 7. Construction Loan Agreement. The proceeds of the loan hereby secured are intended to finance rehabilitation of the Improvements and pursuant to the Construction Loan Agreement between Mortgagor and City of Chicago, Department of Housing; and Mortgagor further covenants and agrees that such rehabilitation shall be completed in accordance with plans and specification approved by and deposited with the Mortgagee.

The occurrence of any default under the Construction Loan Agreement not cured within the time, if any, permitted therein shall constitute a default under this Mortgage. Upon default by Mortgagor in any of the terms, provisions or covenants of the Construction Loan Agreement, the Mortgagee may, but need not, declare the entire unpaid principal balance and all interest accrued under the Note to be immediately due and payable and/or complete the rehabilitation of said Improvements and enter into the necessary contracts therefor. All monies expended to complete such rehabilitation shall be deemed additional indebtedness secured by this Mortgage payable on demand with interest accruing at the default rate set forth in the Note.

8. Transfer and Encumbrance of the Property. The Mortgagor shall not create, effect, contract for, commit to, consent to, suffer or permit any conveyance, sale, assignment, synidication, transfer, lien, pledge, mortgage, security interest or other encumbrance or alienation (or any agreement to do any of the following) of the Premises or any part thereof or interest therein, without the prior written consent of the Mortgages. If the Mortgagor shall do any of the foregoing without the prior written consent of Mortgagee at its option, has the right to accelerate the miturity of the note causing the full principal balance and accrued interest to be immediately die and payable without notice to Mortgagor.

Any waiver by Mortgagee of (h)s paragraph shall not be deemed to be a waiver of the right of Mortgagee to insist upon strict compliance with the provisions of this paragraph in the future.

- 9. Mortgagee's Performance of Defaulted Acts. In case of default herein by Mortgagor, Mortgagee may, but need not, make any payment or perform any act herein required of Mortgagor in any form and manner deemed expedient, and may, but need not, make Yull or partial payments of principal or interest on prior encumbrances of any, and purchase, discharge, compromise or settle any tax lien of other prior lien on title or claim thereof, or redeem from any tax sais or forfeiture affecting said Premises or contest any tax or assessment. All monies paid for any of the purposes herein authorized and [11] expenses paid or incurred in connection therewith, including reasonable attorneys's fees, and any other monies advanced by Mortgagee to protect the Premises and the lien hereof, shall be deemed additional indebtedness secured hereby, and shall become immediately due and payable, with interest thereon at he default interest rate provided for in the Note. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default on the part of Mortgagor.
- 10. Events of Default. It shall constitute a default under this Mortgage when:
 - (a) Mortgagor fails to timely make payment of the Note or any installment thereof, including principal, interest, or any applicable loan fee or other amount required to be paid and such failure continues for five (5) days; or

- (b) Mortgagor fails to duly observe or perform any term, covenant, condition or agreement of this Mortgage, or in the Note, Onstruction Rehabilitation Loan Agreement or any other instrument securing the Note, and said default continues for thirty (30) days; or
- Mortgagor fails to pay any sum due or fails to perform any (c) condition, covenant, term or agreement required under this Mortgage or the note that is secured by this Mortgage; or
- (d) Mortgagor, or any guarantor of the indebtedness secured hereby is:
 - voluntarily adjudicate a bankrupt or insolvent; or,
- seeks or consents to the appointment of a receiver or trustee for itself or for all or any part of its property; or,
 - (iii) Elles a petition seeking relief under or files an answer admitting the material allegations of a petition filed against it under any bankruptcy or similar laws of the United States or the State of Illinois; or,
 - (iv) makes a general assignment for the benefit of creditors; or
 - makes an admission in writing of its inability to pay its (v) debts generally as they become due; or
 - Any order, judgment or decree is encored upon any application of (e) a creditor of Mortgagor by a court of competent jurisdiction appointing a receiver or trustee or custodian of all or a substantial part of the assets of the Morigagor, or approval of any petition filed against Mortgagor hereby seeking relief under any bankruptcy or other similar laws of U.S. or any state and remains in force, undischarged or unstayed for a period of sixty (60) days; or
 - (f)Any warranty, representation, certification, financial statement or other information made or furnished at any time pursuant to the terms of this Mortgage or the Construction Loan Agreement by Mortgagor, or by any person or entity liable for the indebtedness secured hereby, shall prove to be materially inaccurate or false; or
 - (g) Mortgagor transfers, conveys, assigns or sells the Premises or any interest therein or if the mortgagor is a partnership, corporation or land trust, there occurs any assignment or transfer of control of the beneficial interest therein; or
 - (h) Mortgagor abandons the Premises.

- 11. Remedies on Default. If a default under this Mortgage shall occur, murtgagee may at its option, (a) declare the entire indebtedness secured hereby to be immediately due and payable, without notice or demand (each of which is expressly waived by Mortgagor); (b) institute proceedings for the complete foreclosure of the Mortgage; (c) take such steps to protect and enforce its rights whether by action, suit or proceeding in equity or at law for the specific performance of any covenant, condition or agreement in the Note or in this Mortgage; (d) exercise any or all rights and remedies available under the Uniform Commercial Code; and (e) enforce this Mortgage in any other manner permitted under the laws of the State of Illinois.
- 12. Expense of Litigation. In any suit to foreclose the lien of this mortgage or enforce any other remedy of Mortgagee under this Mortgage or the Note or the Construction Loan Agreement, there shall be allowed and included, as additional indebtedness in the judgment or decree, all expenditures and expenses which may be paid or incurred by other related costs and expenses paid or incurred in connection with such proceeding.
- 13. Right of Possession. Subject to the rights of the Mortgagee under this Mortgage, in any case in which, under the provisions of this Mortgage, Mortgagee has a right to institute foreclosure proceedings, whether before or after the institution of such proceedings to foreclose the lien hereof or before or after sale thereunder, Mortgager shall, upon demand of Mortgagee, surrender to mortgagee, and Mortgagee shall be entitled to take actual possession of the Premises or any part thereof, personally or by its agent or attorneys, and Mortgagee, in its discretion may enter upon and take and maintain possession of all or any part of the Premises, together with all documents, books and records.

Upon taking possession of the Premises, the Mortgagee may make all necessary or proper repairs, decoration, renevals, replacements, alterations, addition, betterments, and improvements in connection with the Premises as may seem judicious to Mortgagee to insure, protect and maintain the Premises and all risks incidental to Mortgagee's possession, operation, and management thereof, and to receive all rents, issues and profits therefrom.

Priority of Rent Payments. Any avails, issues and profits of the Premises received by Mortgagee after having possession of the Premises, or pursuant to any assignment thereof to Mortgagee under the provisions of this Mortgage or of any separate Assignment of rents or Assignment of Leases, shall be applied in payment of or on account of the following, in such order as Mortgagee (or in case of a receivership, as the court) may determine: (i) to the payment of operating expenses of the Premises, including reasonable compensation to Mortgagee or the receiver and its agent or agents, (ii) to the payment of taxes, special assessments, and water taxes now due or which may hereafter become due on the Premises, or which may become a

lien prior to the lien of this Mortgage, (iii) to the payment of all repairs decorating, renewals, replacements, alterations, addition, betterments, and improvements of the Premises, including the cost from time to time of installing or replacing personal property or fixtures necessary to the operation of the Premises, (iv) to the payment of any indebtedness secured hereby or any deficiency which may result from any foreclosure sale, or (v) with respect to any overplus or remaining funds, to the Mortgagor, its successors, or assigns, as their rights may appear.

- omplaint to foreclose the lien of this Mortgage, the court may, upon application, appoint a receiver of the Premises. Such appointment may be made either before or after foreclosure sale, without notice, without regard to the solvency or insolvency, at the time of application for such receiver, of the person or persons, of any, liable for the payment of the indebtedness hereby secured, without regard to the value of the Premises at such time and whether or not the same is then occupied as a homestead, and without bond being required of the applicant. Mortgagee or any employee or agent thereof may be appointed as such receiver. Such receiver shall have the power to take possession, control, and care of the Premises and to collect all rents and profite thereof during the pendency of such foreclosure suit.
- 16. Foreclosure Sale. Any real estate or any interest or estate therein sold pursuant to any court order or decree obtained pursuant to the Mortgage shall be sold in one parcel, as an entirety, or in such parcels and in such manner or order as Mortgagee, in its sole discretion, may elect, to the maximum extent permitted by the laws of the State of Illinois. At any such sale, Mortgagee may bid for and acquire, as Purchaser, the Premises or any part thereof, and in lieu of paying cash therefor, may make settlement for the purchase price by crediting upon the indebtedness due the amount of Mortgagee's bid.
- 17. Application of Proceeds from Foreclosure Sale. The proceeds of any foreclosure sale of the Premises shall be distributed and applied in the following order of priority;
 - (a) on account of all costs and expenses incident to the foreclosure proceedings;
 - (b) all other items which, under the terms hereof, constitute secured indebtedness additional to that evidenced by the Note, with interest thereon;

- (c) all principal and interest remaining unpaid on the Note; and,
- (d) any overplus to Mortgagor, its successors, or assigns, as their rights may appear.
- 18. Insurance Upon Foreclosure. In case of an insured loss after foreclosure proceedings have been instituted, the proceeds for any insurance policy or policies, if not applied in restoring the Premises, shall be used to pay the amount due in accordance with any decree of foreclosure that may be entered in any such proceedings, and the balance, if any, shall be paid as the court may direct.
- 19. Paiver of Statutory Rights. Mortgagor shall not apply for or avail itself of any appraisement, valuation, redemption, stay, extension, or exemption laws, or any so-called 'Moratorium Laws', now existing or hereacter enacted, in order to prevent or hinder the enforcement of foreclosure of this Mortgage, and hereby waives the benefit of such laws. Mortgagor, for itself and all who may claim through or under it, waives any and all right to have the property and estates comprising the Premises marshalled upon any foreclosure of the lien hereof and agree; that any court having jurisdiction to foreclose such lien may order the Premises sold as an entirety. The Mortgagor hereby expressly waives any and all rights of redemption from sale under any order or decree of foreclosure of this Mortgage, on its own behalf and on behalf of each and every person having a beneficial interest in Mortgagor, it being the intent hereof that any and all such rights or redemption of the Mortgagor and of all other persons are and shall be deemed to be hereby waived.
- 20. Waiver of Defenses. No action for the enforcement of the lien of this Mortgage shall be subject to any defense which would not be good and available to the party interposing the same in an action of law upon the Note.
- 21. Partial Payments. Acceptance by Mortgagee of any payment which is less than payment in full of all amounts due aid payable at the time of such payment shall not constitute a waiver of Nortgagee's right to exercise its option to declare the whole of the principal sum then remaining unpaid, together with all accrued interest thereon, immediately due and payable without notice, or any other rights of the Mortgagee at the time or any subsequent time, without its profess written consent, except and to the extent otherwise provided by law.
- 22. Delays and Omissions. No delay in the exercise of or failure to exercise any remedy or right accruing or any default under this Mortgage shall impair any such remedy or right or be construed to be a waiver of any such default or acquiescence therein, nor shall in affect any subsequent default of the same or of a different nature.

- 23. Rescission of Election. Acceleration of maturity, once made byMortgagee, may at the option of Mortgagee be rescinded, and any proceedings brought to enforce any rights or remedies herunder may, at Mortgagee's option, be discontinued or dismissed, whereupon, in either of such events, Mortgagor and Mortgagee shall be restored to their former positions, and the rights, remedies and power of Mortgagee shall continue as if such acceleration had not been made or such proceedings had not been commenced, as the case may be.
- 24. Remedies Cumulative and Concurrent. The rights and remedies of Mortgagee shall be cumulative and concurrent and may be pursued separately, successively or together against Morcgagor, any guarantor of the Note, or any one or more of them, at the sole discretion of Mortgagee, and may be exercised as often as occasion therefor shall arise, all to the maximum extent permitted by the laws of the State of Illinois. If Mortgagee elects to proceed under one right or remedy under this Mortgage or the Note, Mortgagee may at any time cease proceeding under such right or remedy and proceed under any other right or remedy under this Mortgage or the Note.
