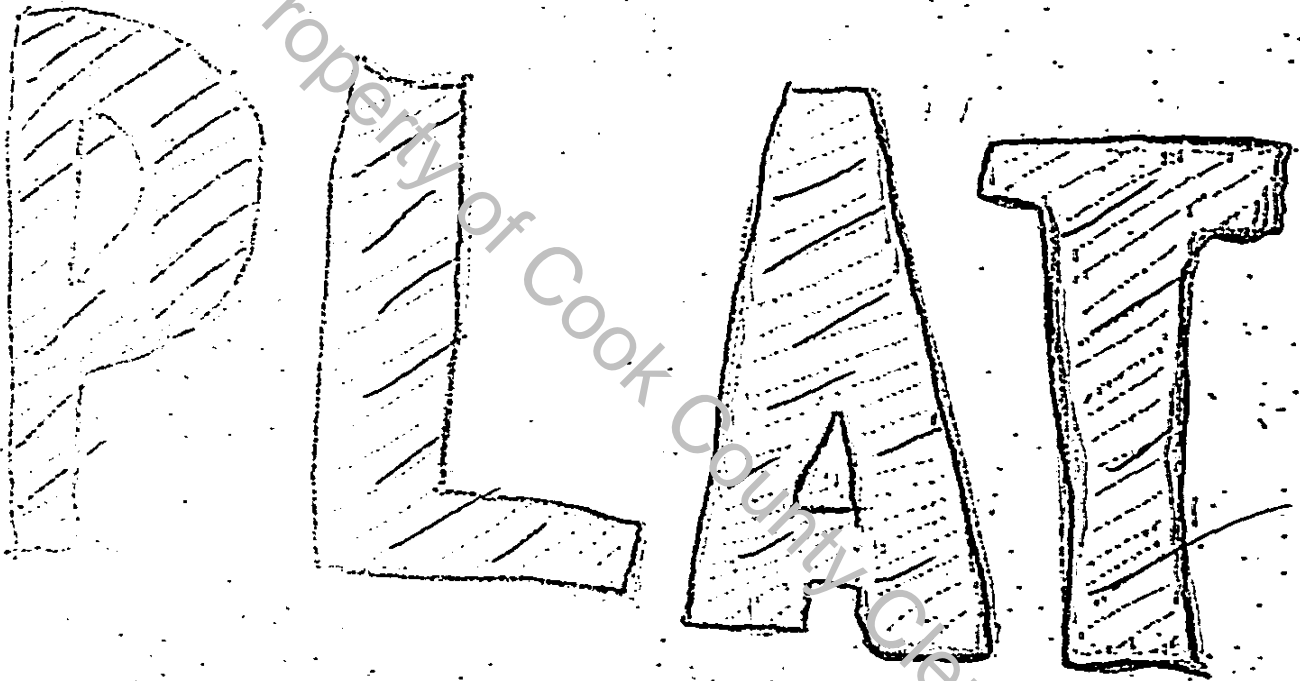

THIS CAUSE COMING TO BE HEARD on the Amended Petition for Disconnection by the Petitioners, HARRIS BANK BARRINGTON, N.A. as Trustee u/t/n 11-3121 and CARMINE NACCARATO, against the VILLAGE OF BARRINGTON HILLS, an Illinois Municipal Corporation, pursuant to and in accordance with Chapter 24, paragraph 7-3-6 of the Illinois Revised Statutes, also known as section 7-3-6 of the Illinois Municipal Code, all parties having notice of these proceedings and the Court being fully advised and informed of the facts of this cause:

WHEREAS, the Court specifically finds that it has jurisdiction over both the subject matter and all of the parties in this cause; and,

WHEREAS, a certain portion of that 77.721 acres of land lies within the corporate limits of the VILLAGE OF BARRINGTON HILLS, which portion is hereafter referred to as the "SUBJECT PROPERTY"; and,

WHEREAS, the VILLAGE has agreed to acquiesce in the disconnection of th SUBJECT PROPERTY pursuant to a settlement agreement entered into by and between CARMINE NACCARATO and the VILLAGE, dated March 16, 1990.

NOW, THEREFORE, in consideration of the above and foregoing recitals, It Is Hereby Adjudged, Ordered and Decreed as follows: The SUBJECT PROPERTY hereby is disconnected from the VILLAGE OF BARRINGTON HILLS.
