- 3. Charges; Liens. Mortgagor shall put of callectob p id all laxes as easy, ments, and other charges, fines, and impositions attributable to the Property: that may attain a priority over this Mortgage, leasehold payments or ground rents, if any, and all payments due under any mortgage disclosed by the title insurance policy insuring Mortgagee's interest in the Property (the "First Mortgage"), if any. Upon Mortgagee's request, Mortgagor shall promptly furnish to Mortgagee receipts evidencing payments of amounts due under this paragraph. Mortgagor shall promptly discharge any lien that has priority over this Mortgage, except the lien of the First Mortgage; provided, that Mortgagor shall not be required to discharge any such lien so long as Mortgagor shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Mortgagee, or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings that operate to prevent the enforcement of the lien or forfeiture of the Property or any part thereof.
- 4. Hazard Insurance. - 10. Forebearance by Mortgagee Not a Waiver. Any forebearance by Mortgagee in exercising any at in coremedy under the Agreement, hereunder, or otherwise afforded by applicable faw, shall not be a waiver of or preclude the exercise of any such right or read dy. The procurement of insurance or the payment of taxes or other liens or charges by fortgagee shall not be a waiver of Mortgagee's right to accelerate the materity of the indebtedness secured by this Mortgage.
- 11. Successors and Assigns Bound; Joit t and Several Liability; Captions. The covenants and agreements herein to anined shall bind, and the rights hereunder shall inure to, the respective successors and assigns of Mortgagee and Mortgager, subject to the provisions of paragraph 16 hereof. All covenants and agreements of Mortgager shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereof.
- 12. Legislation Affecting Mortgagee's Rights. If enactment or expiration of applicable laws has the effect of rendering any provision of the Agreement or this Mortgage unenforceable according to its terms, Mortgagee, at its option, may require immediate payment in full of all sums secured by this Mortgage and may invoke any remedies permitted by paragraph 19.
- 13. Notice. Except for any notice required under applicable law to be given in another manner, (a) any notice to Mortgagor provided for in this Mortgage shall be given by mailing such notice by certified mail addressed to Mortgagor at the Property Address or at such other address as Mortgagor may designate by notice to Mortgagee as provided herein, and (b) any notice to Mortgagee shall be given by certified mail, return receipt requested, to Mortgagee's address stated herein or to such other address as Mortgagee may designate by notice to Mortgagor as provided herein. manner designated begins. 14. Governing Law, Severability. This Mortgage shall be governed by the laws of Illinois. - 15. Mortgagor's Copy. Mortgagor shall be furnished a conformed copy of the Agreement and of this Mortgage at the time of execution or after recordation hereof.
- 16. Transfer of the Property; Assumption. To the extent permitted by law, if all or any part of the Property or an interest therein, including without limitation any part of any beneficial interest in any trust holding title to the Property, is sold or transferred by Mortgagor without Mortgagee's prior written consent, Mortgagee may, at Mortgagee's option, declare all the sums secured by this Mortgage to be immediately due and payable.
