This Mortgage made and entered into as of this 18th day of April, 1991 by and between LaSalle National Trust, N.A., Successor Trustee to LaSalle National Bank?  - (2) personal financial statements for Joseph E. Valenti, Sr. and Adolphe P. Valenti on forms reasonably prescribed by, or approved by, the Mortgagee; and
 - (3) a leasing status report which shall specify for each rental unit the name of the tenant, the identity of the rental unit occupied by such tenant, the annual rental paid therefor and the percentage rental, if any, applicable to such unit, the amount of space being leased, and the lease expiration date.

foreclosure, a sale may be made of the Premises en masse without offering the several parts separately.
