Certificate of Release of Tax Lien

Under the Release of Tax Lien Act, the Department of Revenue is required to issue a certificate of release of tax lien to the owner of property on which a tax lien has been levied and which has been paid in full to the Department of Revenue.

If the taxpayer's request for a certificate of release of tax lien is not in accordance with the provisions of the Release of Tax Lien Act, the Department of Revenue will issue a certificate of release of tax lien only if the taxpayer has paid the tax liability in full to the Department of Revenue.
