WHEREAS, the undersigned are the owners of the single family residence located at 1103 Raleigh Road, Glenview, Illinois, 60025, the legal description being as follows: **PIN. - 04-35-207-073**

LOT 6 IN GLENSHORE SUBDIVISION, BEING A SUBDIVISION OF THE EAST 480.08 FEET OF BLOCK 5 IN HUTCHINGS ADDITION TO OAK GLEN, BEING A SUBDIVISION OF THE SOUTHWEST QUARTER OF THE NORTHEAST QUARTER OF SECTION 35, TOWNSHIP 42 NORTH, RANGE 12, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

AND WHEREAS, the undersigned has submitted an application for a building permit (application #910290) said application being made for the installation of a brick paver driveway and walkway and also for the repair and remodeling and restoration of a certain, presently existing brick planter, located in the front of said residence, and

WHEREAS, said brick planter is located entirely within the Village owned right-of-way and directly abuts the sidewalk lying west of the property, and

WHEREAS, Village of Glenview has a policy which will not permit the repair and restoration and upgrading a brick planter structure located on Village property unless the applicant will execute and deliver to the Village an agreement to hold the Village harmless in the event of any injury or damage to third parties who might be involved in accidents regarding the brick planter in the Village right-of-way.

NOW THEREFORE, in consideration of the Village granting a building permit for the rebuilding of the brick planter and for the other uses specified in the application, the undersigned does agree that they will indemnify and hold harmless the Village of Glenview in the event that any person shall be injured or suffer any damage or costs, or loss of monies attributable to an accident or other happening which involves the aforesaid brick planter located on Village property to the west of the property at 1103 Raleigh Road. It being the intention of this undertaking and agreement that, in the event the Village shall be sued or otherwise held responsible for the payment of any damages to third parties, the Village will be indemnified for all damages, costs, and attorney's fees, and held harmless, and in the event that any third party shall directly seek

damages from the undersigned on account of any accident involving the planter, the undersigned will defend the action and hold the Village harmless with respect to any such action.

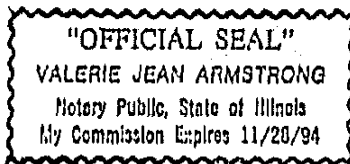
