#### OF VERNON CARL EGLER

I, Vernon Carl Egler, being of sound mind, leave this as my Last Will and Testament. I hereby revoke all previous wills and codicils made by me.

If any portion of this Will is held invalid for any reason, it is my desire that the remaining portions of this Will be honored if at all possible.

My family consists of four children: DAVID G. EGLER; KAREN J. KEELEY; MARRIAINE BELSHAW; and SUSAN R. BROCK, and 8 grandchildren

To execute this Will, I nominate my son David G. Egler. If for any reason he is unable to serve, I nominate his wife, SALLY EGLER. If for any reason she is unable to serve, I nominate my daughter Karen J. Keeley. If for any reason she is unable to serve, I nominate my daughter Marrianne Pelshaw. If for any reason she is unable to serve, I nominate my daughter Susan R. Brock. In any event, my Executor should serve without bond.

I have a CD in joint tenancy with right of servivorship with each of my children. These will not be part of my estate if I die before they do. In any case where that does not happen, I leave the CD to the child or children of that joint tenant.

If any of my chilren owe me money at the time of my death, that debt is forgiven.

Sally Egler is given my car. The household furnishings, tools and equipment are given to David G. Egler and Sally Egler. My personal clothing is given to David G. Egler to distribute.

Each grandchild is given \$1,000.00: The savings account (19,267) is given to David G. Egler to be used for current debts and expenses. There is a life insurance policy (3,000) to be used for funeral expenses. I desire to be cremated, and have as simple a service as is possible. The proceeds from the house contract are to be divided as follows: Each grandchild will receive \$3,000.00. The rest will be divided equally among my four children.

If any of my four children do not survive me, then his or her share will go to his or her surving children per stirpes.

All the rest and residue of my estate shall be divided equally amoung my children.

If anyone under the age of 18 should receive any property under the terms of this Will, chat property should be held in trust until he or she becomes 18. His or her surviving parent or legal guardian should be Trustee, and should serve without bond.
