

Excerpts From Internal Revenue Code

Sec. 6321. Lien For Taxes

If any parson liable to pay any tax requer's or refuses to pay the same siter demand, the amount (including any interest, additional amount, addition to but, or seas table penelty, together with any costs that may accrue in a fiftier thereto, shall be a lien in lever of the finited States upon all property and rights to property, whether real or personal, but uping to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the lie imposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the emount so assessed for a judgment against the taxpayer arising out of such liability) is satisfied or becomes unantorceshie by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors.—The lien impos ed by section 6321 shall not be valid as against any gurchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the require-ments of subsection (i) has been filed by the Secretary).
