AMENDED MECHANIC LIEN NOTICE & CLAIM

Chicago IL U.S. Government, General Services Admin. Chicago IL Dai-ichi Kangyo Bank, Ltd. (Chicago Branch) Chicago IL Canadian Imperial Bank of Commerce Atlanta GA Midwest Indemnity Skokie IL Barclays Bank PLC Chicago IL (hereinafter referred to as "owner") and states:

That on December 20, 1990, the owner owned the following described land in the County of COOK, State of Illinois to wit:

That on December 20, 1990, said contractor made a subcontract with the claimant to provide drywall supplies for and in said improvement, and that on February 20, 1991, the claimant completed thereunder all that was required to be done by said contract. That at the special instance and request of said contractor the claimant furnished extra and additional labor and/or materials on said premises of the value of \$0.00. That said contractor is entitled to credits of account thereof as follows: \$0.00, leaving due unpaid and owing to the claimant, after allowing all credits, the sum of Three Thousand Three Hundred Seventy-seven and 37/100ths (\$3,377.37) Dollars, for which, with interest, the claimant claims a lien on said land and improvements, and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.

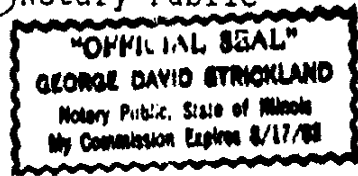
