

UNO SUBRICA A REMOVE OF YOUR

ACREEMENT dated May 14, 1991 between JACK PARIS and LISA PARIS, his wife (Owner), AVENUE BANK OF OAK PARK, Oak Park, State of Illinois, its Successors and/or its Assigns, (Lender) and AVENUE BANK OF OAK PARK (Mortgagee).

The parties recite and declare that:

A. - 2. Owner and Mortgagee are familiar with the terms of the lock Lender proposes to make to Mortgagor and hereby approve the terms of said loan.
- 3. This agreement shall be binding upon and inure to the benefit of the respective heirs, legal representatives, successors, and assignees of the parties hereto.
