Improvements. The word "improvements" means and includes without limitation all existing and future improvements, futures, buildings, structures, mobile homes affixed on the Real Property, facilities, additions and other construction on the Real Property.

Indebtedness. Compliance with Governmental Requirements. Grant r shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the "Forty. Grantor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including apy ror rigit appeals, so long as Grantor has notified Lender in writing prior to doing so and so long as Lender's interests in the Property are not jecuar and. Lender may require Grantor to post adequate security or a surety bond, reasonably satisfactory to Lender, to protect Lender's interest.

Duty to Protect. Grantor agrees neither to abandon nor leave unlittent ed the Property. Grantor shall do all other acts, in addition to those acts set torth above in this section, which from the character and use of the Property are reasonably necessary to protect and preserve the Property.

- 5. COMPLIANCE WITH LEASE. - 6. REHABILITATION LOAN AGREEMENT. Grantor shall fulfill all of Grantor's obligations unifer am home rehabilitation, improvement, repair, or other loan agreement which Grantor may enter into with Lender. Lender, at Lender's option, may require Crentor to execute and deliver to Lender, in a form acceptable to Lender, an assignment of any rights, claims or defenses which Grantor may have against parties who supply labor, materials or services in connection with improvements made to the Property.
- 7. DUE ON SALE CONSENT BY LENDER. Notice of Transfer. Grantor shall give notice to Lender, as provided in this Mortgage, prior to any sale or transfer of all or part of the Property or any rights in the Real Property. Any person to whom all or part of the Real Property is sold or transferred also shall be obligated to give notice to Lender, as provided in this Mortgage, promptly after such transfer.

Advances After Transfer. All amounts advanced under the LOANLINER® Home Equity Plan Credit Agreement, up to the Credit Limit, are secured by this Mortgage, whether advanced before or after sale or transfer of the Real Property, except any amounts which may be advanced by Lender more than five (5) days after notice to Lender, as provided in this Mortgage, that such transfer or sale has occurred. Even it Grantor transfers the Real Property, Grantor will continue to be obligated under the Credit Agreement and this Mortgage unless Lender releases Grantor writing. As a condition to Lender's consent to any proposed transfer or as a condition to the release of Lender may require that the person to whom the Real Property is transferred sign an assumption agreement satisfactory to Lender and Lender may impose an assumption fee. The assumption agreement will not entitle the person signing it to receive advances under the Credit Agreement.

TAXES AND LIENS. The lollowing provisions relating to the taxes and liens on the Property are a part of this Modgage.

Payment. Grantor shall pay when due (and in all events prior to delinquency) all taxes, payroll taxes, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of all liens having priority over or equal to the interest of Lender under this Mortgage, except for the lien of taxes and assessments not due, except for the Existing Indebtedness referred to below, and except as otherwise provided in the following paragraph.

Right To Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good faith dispute over the obligation to pay, so long as Lender's interest in the Property is not jeopardized. It a lien arises or is filed as a result of nonpayment, Grantor shall within fifteen (15) days after the lien arises or, it a lien is filed, within fifteen (15) days after Grantor has notice of the filing, secure the discharge of the lien, or if requested by Lender, deposit with Lender cash or a sufficient corporate surely bond or other security satisfactory to Lender in an amount sufficient to discharge the lien plus any costs and attorneys' lees or other charges that could accrue as a result of a foreclosure or sale under the lien. Evidence of Payment. Grantor shall upon demand furnish to Lender satisfactory evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

Notice of Construction. Granter shall notify Lender at least fifteen (15) days before any work is commenced, any services are furnished, or any

materials are supplied to the Property, if any mechanic's lien, materialmen's lien, or other tien could be asserted on account of the work, services, or materials and the cost exceeds \$10,000.00. Grantor will upon request of Lender furnish to Lender advance assurances satisfactory to Lender that Grantor can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE. The following provisions relating to insuring the Property are a part of this Mortgage.

Maintenance of Insurance. Grantor shall produre and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any consurance clause, and with a standard mortgagee clause in favor of Lender. If the Real Property is located in an area dosignated by the Director of the Federal Emergency Management Agency as a special flood of hazard area, Grantor agrees to obtain Federal Flood Insurance loss such insurance is required and is available for the term of the toan and for the full unpaid principal balance of the toan. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender certificates of coverage from each insurer containing a stiputation that coverage will not be cancelled or diminished without a minimum of lan (10) days" prior written notice to Lender.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property if the estimated cost of repair or replacement exceeds \$10,000.00. Lender may make proof of loss if Grantor fails to do so within fifteen [15] days of the casualty. It in Lender's judgment, the restoration or repair is economically feasible and Lender's security is not lessened, insurance proceeds shall be applied to restoration or repair of the damaged Property. If the restoration or repair is not economically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Mortgage whether or not then due, with any excess paid to Grantor. If Grantor had abandors the Property, or does not answer within thirty (30) days a notice from Lender that the insurance camer has offered to settle a claim, then Lender may collect the insurance proceeds. Lender may use the proceeds to repair or restore the Property or to pay sums secured by this Mortgage, whether or not then due.

Unexpired insurer le at Sale. Any unexpired insurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by this Micropage at any bustless sale or other sale held under the provisions of this Micropage, or at any foreclosure sale of such Property.

Compliance with Existing Indebtedness. During the period in which any Existing Indebtedness described below is in effect, compliance with the insurance provisions contained in the insurance provisions under this Mortgage. In the assert compliance with the terms of this Mortgage would constitute a duplication of insurance requirement. If any proceeds from the insurance payable on loss, the provisions in this Mortgage for durison of proceeds shall apply only to that portion of the proceeds and payable to the solder of the Existing Indebtedness.

- 11. EXPENDITURES BY LENDER. If Girlior fails to comply with any provision of this Mortgage, including any obligation to maintain Existing Indebtedness in good standing as require, fieldw, or diany action or proceeding is commenced that would materially affect Lender's interests in the Property, Lender on Grantor's behalf may, upon notice to Grantor, but shall not be required to, take any action that Lender deams appropriate. Any amount that Lender expands in so doing will bear interest at the rate charged under the Credit Agreement from the date incurred or paid by Lender to the date of repayment by Grantor. Title. Defense of Title. Subject to the exception in the paragraph at ove, Grantor warrants and will forever defend the title to the Property against the tawful claims of all persons. In the event any action or proceeding in con imenced that questions Grantor's little or the interest of Lender under this Mortgage, Grantor shall defend the action at Grantor's expense. Grantor may be the nominal party in such proceeding, but Lender shall be entitled to participate in the proceeding and to be represented in the union by coursel of Lender's own choice, and Grantor will definer, or cause to be delivered, to Lender such instruments as Lender may reque if the time to permit such participation.

Compliance With Laws. Grantor warrants that the Property and Gran or, use of the Property complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

13. EXISTING INTERTEDNESS. The following provisions concerning existing indebted iers (the 'Existing Indebtedness') are a part of this Mortgage.

Existing Uen. The sen of this Mortgage securing the Indebtedness may be secondary and interior to an existing Sen, if there is such a Sen. Grantor expressly covenants and agrees to pay, or see to the payment of, the Existing undebtedness and to prevent any default on such indebtedness, any default under the instruments evidencing such indebtedness, or any default under any security documents for such indebtedness.

No Modification. Grantor shall not enter into any agreement with the holder of any mortgage, direct of trust, or other security agreement which has priority over this Mortgage by which that agreement is modified, amended, extended, or recover of without the prior written consent of Lender. Grantor shall neither request nor accept any future advances under any such security agreement within a the prior written consent of Lender.

14. CONDEMNATION. The following provisions relating to condemnation of the Property are a part of this stortings.

Application of Net Proceeds. If all or any part of the Property is condemned, Lender may at its election is equire that all or any portion of the met proceeds of the award be applied to the Indebtedness under the LOANLINER® Home Equity Plan, subject to the award of any mortgage or deed of trust with a lien which has priority over this Mortgage. The net proceeds of the award shall mean the award a lier or yment of all reasonable costs, expenses, and attorneys' fees necessarily paid or incurred by Grantor or Lender in connection with the condemnation.

Proceedings. If any proceeding in condemnation is filed, Grantor shall promptly notify Lender in writing, and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award. Taxes. The following shall constitute taxes to which this section applies: (a) a specific tax upon this type of Mortgage or upon all or any part of the Indebtedness secured by this Mortgage; (b) a specific tax on Grantor which Grantor is authorized or required to deduct from payments on the Indebtedness secured by this type of Mortgage; (c) a tax on this type of Mortgage chargeable against the Lender or the holder of the Credit and Agreement; and (d) a specific tax on all or any portion of the Indebtedness or on payments of principal and interest made by Grantor.

16. FURTHER ASSURANCES. The following provisions relating to further assurances are a part of this Mortgage.

Fortner Assurances. Upon request of Lender, Grantor will make, execute and deliver, or will cause to be made, executed or delivered, to Lender, or in Lender's designee, and when requested by tender, cause to be filed, recorded, refired, or rerecorded, as the case may be, as such times and it is such offices and places as Lender may deem appropriate, any and all such mortgages, deeds of final, security deeds, security agreements, financing statements, continuation statements, instruments of further assurance, certificates, and other documents as may, in the sole opinion of Lender, be necessary or desirable in order to effectuate, complete, perfect, continue, or preserve. (a) the obligations of Grantor under the Credit Agreement, this Mortgage, and the Related Documents, and. (b) the tiens and security interests created by this Mortgage on the Property. Unless prohibited by law or agreed to the contrary by Lender in writing, Grantor shall reimburse Lender for all costs and expenses incurred in connection with the matters referred to in this paragraph.

17. FULL PERFORMANCE. If Grantor days all the Indebtedness when due, terminates the credit line account, and otherwise performs all tight obligations imposed upon Grantor under this Mortgage, Lender shall execute and deliver to Grantor a suitable satisfaction of this Mortgage. Grantor way, if permitted by applicable law, any reasonable termination fee as determined by Lender from time to time.

15. DEFAULT. Each of the following, at the option of Lender, shall constitute an event of default ("Event of Default") under this Morlgage: (a) Grant commits traud or makes a material misrepresentation at any time in connection with the credit line account. This can include, for example, a laise statement about Grantor's income, assets, liabilities, or any other aspects of Grantor's financial condition. (b) Grantor does not meet the repayment terms of the credit line account. (c) Grantor's action or inaction adversely affects the collateral for the credit line account or Lender's rights in the collateral. The notice shall further inform Grantor of the right to reinstate after acceleration and the right to assert in a foreclosure proceeding the nonexistence of an event of default or any other defense of Grantor to acceleration and sale.
