LEGAL DESCRIPTION

PARCEL 1

That portion of the West 600 feet of Lot 101 of Sanitary District Trustees' Subdivision of Right-of-Way from North & South Center line of Section 30, Township 39 North, Range 14 East of the Third Principal Meridian to Will County line lying between lines parallel to and respectively, 11 feet and 25 feet normally distant Southeasterly from the center line of the main tract of the Sanitary District Sludge Railroad except Harlem Avenue, situated in the Village of Forest View, County of Cook and State of Illinois.
