TOGETHER WITH all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalites, mineral, oil and gas rights and profits, unline or demands with respect to insurance, any and all awards made for the taking by eminent domain, water do its and stock and all fixtures now or hereafter a part of the property.
