2. Immediately upon the recording of this instrument the aforesaid Parking Space Number 2 shall henceforth be considered and treated as appurtenant to and shall run with the title to Unit Number N1 in the 4629-31 North Malden Condominium.


3. This Agreement shall be binding upon and shall inure to the parties hereto and their successors and assigns and to any person having at any time any interest or estate in the property described above.


