- 1. The foregoing recitals are incorporated by reference herein and made a part hereof, same constituting the factual basis for this transaction.
- 2. The Lease aforesaid is incorporated by reference herein and made a part hereof as if set forth in full.

- 3. The District for itself, its successors and assigns hereby consents to and approves the assignment of Lease/Sublease of the demised premises by Robert J. Ciserella to Joseph Cistaro, individually and surviving sole general partner of C & C Partnership, as aforesaid.
- 4. This Consent to Sublease does not operate as a release of liability of any signatory on said Lease, either personally or acting as a general partner for C & C Partnership.
- 5. Joseph Cistaro agrees to be personally bound unto the District for the faithful, complete and timely performance of each and every undertaking and promise of C & C Partnership, Robert J. Ciserella and Joseph Cistaro, pursuant to the Lease.
- 6. The reappraisal of the premises pursuant to Paragraph 7.06 of the Lease, for purposes of rental adjustment incident to an assignment of Lease/Sublease is waived as to this transaction. The reappraisal scheduled to occur in 1993 is not waived.
