That on January 29, 1991, the owner owned the following described land in the County of Cook, State of Illinois, to wit: LOT 9 IN BLOCK 4 IN MCPEPPERLAND ALLESTON'S ADDITION TO CHICAGO, A SUBDIVISION OF BLOCK 25 IN CANAL TRUSTEES' SUBDIVISION OF SECTION 33, TOWNSHIP 39 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, IN COOK COUNTY, ILLINOIS.

That on January 29, 1991, the claimant made a contract with ~~CONTRACTOR~~  
 (1) Parker Taylor d/b/a Michael Aluminum and Construction Co., authorized or knowingly permitted by said owner, to make said contract whereby subcontractor Hubert Marcinkiewicz d/b/a Hubert's Home Improvement agreed to perform certain work, namely the following:  
 (2) to install siding on rear porch, vinyl on exterior windows, insulation, shelving, paint interior, light, electric baseboard heaters, canopy over door, chalk exterior brick, 8'x10' deck on rear porch, insulation ceiling and 2' outside, vinyl on rear floor, exterior, interior, exterior trim, exterior wall.  
 for the building (3) a 2 story building was erected on said land for the sum of \$ 8,300.00  
 and on March 18, 1991, completed (4) all work specified  
 Above and all work required to be done

That at the special instance and request of said owner the claimant furnished extra and additional materials and extra and additional labor on said premise, of the value of \$ 500.00 and completed same on March 18, 1991. (3)

This said owner is entitled to credits on account thereof as follows, to wit: No credits are due

leaving due, unpaid and owing to the claimant, after allowing all credits, the balance of \$8,800 Eight Thousand Eight Hundred Dollars, for which, with interest, the claimant claims a lien on said land and improvement.
