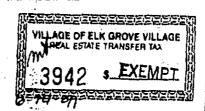

- 13. Governing Law; Severability. The state and local laws applicable to this Mortgage shall be the laws of the jurisdiction in which the Property is located. The foregoing sentence shall not limit the applicable law to this Mortgage. In the event that any provision or clause of this Mortgage or the Note conflicts with applicable law such conflict shall not affect other provisions of this Mortgage or the Note which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Note are declared to be severable. As used heroin, "costs", "expenses" and "afformacys' fees" include all sums to the extent not prohibited by applicable law or limited herein.
- 14. Borrower's Copy. Borrower shall be furnished a conformed copy of the Note and of this Mortgage at the time of execution or after recordation hereof.
- 15. Rehabilitation Loan Agreement. Borrower shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, repair, or other loan agreement which Borrower enters into with Lender. Lender, at Lender's option, may require Borrower to execute and deliver to Lender, in a form acceptable to Lender, an assignment of any rights, claims or defenses which Borrower may have against parties who supply labor, materials or services in connection with improvements made to the Property.
- 16. Transfer of the Property or a Beneficial Interest in Borrower. If all or any part of the Property or an interest them in a sold or transferred by Borrower (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person or persons but is a corporation, partnership, trust or other legal entity) without Lender's prior written consent, excluding (a) the creation of a iten or encumbrance subordinate to this Sacurity Instrument which does not relate to a transfer of rights of occupancy in the property. (b) the creation of a purchase money succust, interest for household appliances (c) a transfer by devise, descent or by operation of law upon the death of a joint tenant or (d) the grant or any loasehold interest of three years or less not containing an option to purchase, Lender may, at Lender's option, declare all the sums seculed by this Security Instrument to be immediately due and payable.

If Lender exercises such option to accelerate, Lender shall mail Borrower notice of acceleration in accordance with paragraph 12 hereof. Such notice shall provide a point of not less than 30 days from the date the notice is mailed within which Borrower may pay the sums declared due. If Borrower fails to pay such sums prior to the expiration of such period, Lender may, without further notice or demand on Borrower, invoke any remedies perintific by paragraph 17 hereof.

Lender may consent to a sale of transfer if: (1) Borrower causes to be submitted to Lender information required by Lender to evaluate the transferse as if a new loan were being made to the transferse; (2) Lender reasonably determines that Lender's security will not be impaired and that the risk of a breach of any corporant or agreement in this Security Instrument is acceptable; (3) Interest will be payable on the sums secured by this Security Instrument at a rate acceptable to Lender; (4) changes in the terms of the Note and this Security Instrument required by Lender are made, including, for example, pelodic adjustment in the interest rate, a different final payment date for the loan, and addition of unpaid interest to principal, and (5) the transferse signs an assumption agreement that is acceptable to Lender and that obligates the transferse to keep all the promises and agreements minds in the Note and in this Security Instrument, as modified if required by Lender. To the extent permitted by applicable law, Lender also may charge a reasonable fee as a condition to Lender's consent to any sale or transfer.

Borrower will continue to be obligated under the Note and this Sourity Instrument unless Lender releases Borrower in writing. NON-UNIFORM COVENANTS. Borrower and Lender further (overlant and agree as follows:

- 17. Acceleration; Remedies. Except as provided in pararianh 16 hereof, upon Borrower's breach of any covenant or agreement of Borrower in this Mortgage, including the covenants to ply when due any sums secured by this Mortgage, Lender prior to acceleration shall give notice to Borrower as provided in paragraph 12 hereof specifying: (1) the breach; (2) the action required to cure such breach; (3) a date, not less than 10 days from the ria'r, the notice is mailed to Borrower, by which such hreach must be cured; and (4) that failure to cure such breach on or bifole the date specified in the notice may result in acceleration of the sums secured by this Mortgage foreclosure by judicial proceeding, and sale of the Property. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to assert in the foreclosure proceeding the nonexistence of a default or any other defense of Borrower to acceleration and foreclosure. If the breach is not cured on or before the date specified in the notice, Lender, at Lender's option, may declare all of the sums secured by this Mortgage to be immediately due and payable without further demand and may foreclose this Mortgage by judicial proceeding. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to make attorneys' fees and costs of documentary evidence, abstracts and title reports.
- 18. Borrower's Right to Reinstate. Notwithstanding Landor's acceleration of the sums a cured by this Mortgage due to Borrower's breach, Borrower shall have the right to have any proceedings begun by Londer to enforce this Mortgage discontinued at any time prior to the entry of a judgment enforcing this Mortgage it: (a) Borrower pays Lender all sums which wor'd be then due under this Mortgage and the Note had no acceleration occurred; (b) Borrower cures all breaches of any other covenants or refreements of Borrower contained in this Mortgage; (c) Borrower pays all reasonable expenses incurred by Lender in enforcing the covenants and agreements of Borrower contained in this Mortgage, and in enforcing Lender's remedies as provided in paragraph 17 hereof, Including, but not limited to, reasonable attorneys' lees; and (d) Borrower takes such action as Lender may reasonably require to assure that the let 1 this Mortgage, Lender's interest in the Property and Borrower's obligation to pay the sums secured by this Mortgage shall continue unimpaired. Upon such payment and cure by Borrower, this Mortgage and the obligations secured hereby shall remain in full force and effect as if no acceleration had occurred.
- 19. Assignment of Rents; Appointment of Receiver. As additional security hereunder, Borrower hereby assigns to Lender the rents of the Property, provided that Borrower shall, prior to acceleration under paragraph 17 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

Upon acceleration under paragraph 17 hereof or abandonment of the Property, Lender shall be entitled to have a receiver appointed by a court to enter upon, take possession of and manage the Property and to collect the rents of the Property Including those past due. All rents collected by the receiver shall be applied first to payment of the costs of management of the Property and collection of rents, including, but not limited to, receiver's fees, premiums on receiver's bonds and reasonable attorneys' fees, and then to the sums secured by this Mortgage. The receiver shall be fiable to account only for those rents actually received.

- 20. Release. Upon payment of all sums secured by this Mortgage, Lender shall release this Mortgage without charge to Borrower. Borrower shall pay all costs of recordation, if any.
 - 21. Walver of Homestead. Borrower hereby waives all rights of homestead exemption in the Property.
