Improvements. The word "improvements" means and includes without limitation all existing and future improvements, fixtures, buildings, structures, mobile homes affixed on the Real Property, Inclifies, additions and other construction on the Real Property.

Indebtedness. The word "Indebtedness" mouns all principal and interest payable under the Credit Agreement and any amounts expended or advanced by Lander to discharge obligations of Granter under this Mortgage, logether with interest on such amounts as provided in this Mortgage. Specifically, without limitation, this Mortgage secures a revolving line of credit, which obligates Lentier to make advances to Grantor so long as Grantor complies with all the terms of the Credit Agreement.
Such advances may be made, repaid, and remade from lime to time, subject to the limitation that the total outstanding balance owing at Such advances may be made, repaid, and remade from time to time, subject to the immitation that the total outstanding balance owing at any one time, not including finance charges on such balance at a fixed or variable rate or sum as provided in the Credit Agreement, any temporary overages, other charges, and any amounts expended or advanced as provided in this paragraph, shall not exceed the Credit Limit as provided in the Credit Agreement. G: PAYMENT AND PERFORMANCE. Except as otherwise provided in this Mortgage, Grantor shall pay to Lender all amounts secured by this Mortgage as they become due, and shall strictly perform all of Grantor's obligations under the LOANLINER® Home Equity Plan Cradit Agreement and under this Mortgage.

4." POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that Grantor's possession and use of the Proporty shall be governed by the following provisions:

Hazardous Subrictors. Grantor represents and warrants that the Property never has been, and never will be so long as this Mortgago remains a lien on the Property, and for the generalism, manufacture, storage, treatment, disposal, release or threatened release of any hazardous waste or substance, as those forms are defined in the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. Section 9601, (1994, ("CERCLA"), the Superfund Amendments and Reauthorization Act ("SAR"), applicable state or Federal laws, or logications adopted purposition any of the foregoing. Grantor authorizes Lender and its agents to enter upon the Property to make such inspections and lesis as funder may doom appropriate to determine compliance of the Property with this section of the Mortgage. Grantor hereby (a) releases and waives any fund claims against Lender for Indemnity or contribution in the event Grantor becomes liable for cleanup or other costs under any such laws, and (t) agrees to indemnity and hold harmless Lender against any and all claims and losses resulting from a breach of this paragraph of the Mortgage. This obligation to indemnity shall survive the payment of the Indebtedness and the satisfaction of this Mortgage.

Nulsance, Waste. Grantor shall not cause, conduct or permit any nuisance nor commit, permit, or suffer any stripping of or waste on or to the Property or any portion of the Property. Specifically without limitation, Grantor will not remove, or grant to any other party the right to remove, any timber, minerals (including oil and gas), soil, or or ock products without the prior written consent of Lender.

Lender's Right to Enter, Lender and its agents and representatives may enter upon the Real Property at all reasonable times to attend to Lender's Interests and to Inspect the Property for ruspoles of Grantor's compliance with the terms and conditions of this Mortgage.

Compliance with Governmental Requirements. Organic shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such law, ordinance, or regulation who withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and so long as Lender's interests in the Property are not increased. Lender may require Grantor to post adequate security or a surely bond, reasonably satisfactory to Lender, to protect Lender's interest.

Duty to Protect. Grantor agrees neither to abandon nor leave uninterded the Property. Grantor shall do all other acts, in addition to those acts set forth above in this section, which from the character and use of the Property are reasonably necessary to protect and preserve the Property.

- 5. COMPLIANCE WITH LEASE. If there is a Lease on the Property, Grant x vill pay all rents and will strictly observe and perform on a limity basts all other terms, covenants, and conditions of the Lease, either orally or in writing, without Lender's prior written consent. No estate in the Property, whether for title to the leasehold premises, the leasehold estate, or any subleasehold citate, will morge without Lender's express written consent; rather these estates will remain separate and distinct, even if there is a union of these erials in the lendford, Grantor, or a third party who purchases or otherwise acquires the estates. Grantor further agrees that if Grantor acquires all or a portion of the les simple title, or any other leasehold or subleasehold litin to the Property, that title will, at Lender's option, immediately become expect to the terms of this Mortgage, and Grantor will execute, deliver and record all documents necessary or appropriate to assure that such title is secured by this Mortgage.
- 6. REHABILITATION LOAN AGREEMENT. Grantor shall fulfill all of Grantor's obligations ut der any home rehabilitation, improvement, repair, or other loan agreement which Grantor may enter into with Lender. Lender, at Lender's option, may require Grantor to execute and deliver to Lander, in a form acceptable to Lender, an assignment of any rights, claims or defenses which Grantor may have ar a in I parties who supply labor, materials or services in connection with improvements made to the Property.
- 7. DUE ON BALE CONSENT BY LENDER. Lender may, at its option, have the right to accelerate, the its, declare immediately due and payable all sums secured by this Mortgage upon the sale or transfer, without the Lender's prior written consent of Lender, then, prior to acceleration Lender shall give notice to Grantor. The notice shall provide a period of not less than ten (10) days from the date of the holice within which Grantor may pay the sums declared due. If Grantor fails to pay those sums prior to the expiration of such period, Lander may, without surth a notice or demand on Grantor, invoke any remedies permitted in this Mortgage. A "sale or transfer" means the conveyance of Real Property or a yight, title or interest therein; whether logal or equitable; whother voluntary or involuntary; whether by outright sale, deed, installment sale continuity to contract, contract for deed, leasehold interest with a form greater than three (3) years, lease-option contract, or by sale, assignment, or transfer of any period interest in or to any lend trust holding title to the Real Property, or by any other method of conveyance of Real Property interest. However, this position shall not be exercised by Lender II such exercise is prohibited by tederal law or by Illinois law.
- 8. TRANSFER OF PROPERTY. The following provisions rotating to the transfer of the Real Property are a part of this Montgage.

Notice of Transfer. Graniol shall give notice to Lender, as provided in this Mortgage, prior to any sale or transfer of all or part of the Property of any rights in the Real Property. Any person to whom all or part of the Real Property is sold or transferred also shall be obligated to give notice to Lender, as provided in this Mortgage, promptly after such transfer.

Advances: After Transfer: All amounts advanced under the LOANLINER® Home Equity Plan Credit Agreement, up to the Credit Limit, are secured by this Morigage, whether advanced before or after sale or transfer of the Real Property, except any amounts which may be advanced by Lender more than five (5) days after notice to Lender, as provided in this Morigage, that such transfer or sale has occurred. Even if Grantor transfers the Real Property, Grantor will continue to be obligated under the Credit Agreement and this Morigage unless Lender releases Grantor in writing. As a condition to Lender's consent to any proposed transfer or as a condition to the release of Grantor, Lender may require that the person to whom the Real Property is transferred sign an assumption agreement satisfactory to Lender and Lender may impose an assumption fee. The assumption agreement will not entitle the person signing it to receive advances under the Credit Agreement.

9, TAXES AND LIENS. The following provisions relating to the taxes and tiens on the Property are a part of this Mortgage.

Payment. Grantor shall pay when due (and in all events prior to delinquency) all taxes, payroll taxes, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of all tiens having priority over or equal to the interest of Lender under this Mortgage, except for the lien of taxes and assessments not due, except for the Existing indebtedness reterred to below, and except as otherwise provided in the following paragraph.

Right To Contest. Grantor may withhold payment of any tax, assessment, or claim in connection with a good fallh dispute over the obligation to pay, so long as Lender's interest in the Property is not jeopardized. If a lien arises or is liked as a result of nonpayment, Grantor shall within lifteen (15) days after the lien arises or, if a lien is liked, within fifteen (15) days after Grantor has notice of the filling, secure the discharge of the lien, or if requested by Lender, deposit with Lender cash or a sufficient corporate surety bond or other security satisfactory to Lender in an amount sufficient to discharge the lien plus any costs and attorneys' less or other charges that could accrue as a result of a toreclosure or sate under the lien. In any contest, Grantor shall defend itself and Lender and shall satisfy any adverse judgment before enforcement against the Property. Grantor shall name Lender as an additional obligae under any surely bond furnished in the contest proceedings.

Evidence of Payment. Grantor shall upon demand turnish to Lender satisfactory evidence of payment of the taxes or assessments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

Notice of Construction. Granior shall notify Lender at least fitteen (15) days before any work is commenced, any services are furnished, or any

materials are supplied to the Property, If any mechanic's lien, materialmen's lien, or other lien could be asserted on account of the work, services, or materials and the cost exceeds \$10,000.00. Granter will upon request of Lender furnish to Lender advance assurances satisfactory to Lender that Granter can and will pay the cost of such improvements.

10. PROPERTY DAMAGE INSURANCE. The following provisions rolating to insuring the Property are a part of this Modgage.

Maintenance of insurance. Granter shall produce and maintain policies of fire insurance with standard extended coverage endorsoments on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance clause, and with a standard mortgagee clause in favor of Lender. If the Real Property is located in an area designated by the Director of the Federal Emergency Management Agency as a special flood hazard area, Granter agrees to obtain Federal Flood insurance to the extent such insurance is required and is available for the term of the loan and for the full unpaid principal balance of the loan. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Granter shall deliver to Lender certificates of coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of ten (10) days' prior written notice to Lender.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property if the estimated cost of repair or replacement exceeds \$10,000.00. Lender may make proof of loss if Grantor tails to do so within tifteen (15) days of the casualty. If, in Lender's judgment, the restoration or repair is economically feasible and Londer's security is not lessened, insurance proceeds shall be applied to restoration or repair of the damaged Property. If the restoration or repair is not economically feasible or Londer's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Mortgage whether or not then due, with any excess paid to Grantor. If Grantor abandons the Property, or does not answer within thirty (30) days a notice from Lender that the Insurance carrier has offered to settle a claim, then Lender may collect the insurance proceeds. Lender may use the proceeds to repair or restore the Property or to pay sums secured by this Mortgage, whether or not then due.

Unexpired Insurance at Sale. Any unexpired insurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by this Mortgage at any trustee's sale or other sale held under the provisions of this Mortgage, or at any foreclosure sale of such Property.

Compliance with Existing Indebtedness. During the period in which any Existing Indebtedness described below is in effect, compliance with the insurance provisions domained in the instrument evidencing such Existing Indebtedness shall constitute compliance with the insurance provisions under this Mortgage, to the extent compliance with the terms of this Mortgage would constitute a duplication of insurance requirement. If any proceeds from the insurance obscome payable on loss, the provisions in this Mortgage for division of proceeds shall apply only to that portion of the proceeds not payable to the Existing Indebtedness.

- 11. EXPENDITURES BY LENDER. If Grantor fulls to comply with any provision of this Mortgage, including any obligation to maintain Existing indebtodness in good standing as required, below, or if any action or proceeding is commenced that would materially affect Lender's interests in the Property, Lender on Grantor's behalf may, upon notice to Grantor, but shall not be required to, take any action that Lander doesns appropriate. Any amount that Lender expends in so doing will bear interest at the rule charged under the Credit Agreement from the date incurred or path by Lender to the date of repayment by Grantor. All such expenders option, will (a) be payable on demand, or (b) be added to the balance of the credit line. This Mortgage also will secure payment of the authority in the register provided for in this paragraph shall be in addition to any other rights or any remedies to which Lender may be entitled on account of the default. Any such action by Lender shall not be construed as curing the default so as to bar Lender from any remedy that it otherwise would have read.
- 12. WARRANTY; DEFENSE OF TITLE. The following provisions rotating to ownership of the Property are a part of this Mortgage.

Title. Grantor warrants that: (a) Grantor holds good and reachable little of record to the Property (including a leasehold interest, it any), thee and clear of all liens and encumbrances except those of record, and (b) Grantor has the full right, power, and authority to execute and deliver this Mortgage to Leader.

Detense of Title. Subject to the exception in the paragraph allows, Grantor warrants and will forever defend the title to the Property against the tawful claims of all persons. In the event any action or processing is commenced that questions Grantor's title or the interest of Londer under this Mortgage, Grantor shall detend the action at Grantor's expense. Grantor may be the nominal party in such proceeding, but Londer shall be entitled to participate in the proceeding and to be represented in the proceeding by counted of Lender's own choice, and Grantor will deliver, or cause to be delivered, to Londer such instruments as Lender may request from time to time to permit such participation.

Compliance With Laws. Granior warrants that the Property and Granior's use of the Property complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

13. EXISTING INDEBTEDNESS. The following provisions concerning existing indebt of runs (the "Existing Indebtedness") are a part of this Mortgage.

Existing Lien. The lien of this Mortgage securing the indebtedness may be seccretary and interior to an existing lien, if there is such a lien. Grantor expressly covenants and agrees to pay, or see to the payment of, the Existing Indebtedness and to prevent any default on such indebtedness, any default under the instruments evidencing such indebtedness, or any default under any security decriments for such indebtedness.

No Modification. Granter shall not enter into any agreement with the holder of any merigage, and of trust, or other security agreement which has priority over this Mortgage by which that agreement is modified, amended, extended, or removed without the prior written consent of Lender. Granter shall neither request nor accept any future advances under any such security agreement without the prior written consent of Lender.

14. CONDEMNATION. The following provisions relating to condemnation of the Property are a part of this Advicage.

Application of Nat Proceeds. If all or any part of the Property is condumned, Lunder may at its election of equive that all or any portion of the net proceeds of the award be applied to the Indebtedness under the LOANLINERS Home Equity Plan, subject to Pullyms of any mortgage or deed of trust with a lien which has priority over this Mortgage. The net proceeds of the award shall mean the award after pryment of all reasonable costs, expenses, and alternays less necessarily paid or incurred by Granter or Lender in connection with the condemnation.

Proceedings. If any preceding in condomnation is filed, Grantor shall promptly notify Lender in writing, and Clar or shall promptly take such stops as may be necessary to defend the action and obtain the award. Grantor may be the nominal party in such proceeding, but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver or cause to be delivered to Lender such instruments as may be requested by it from time to time to permit such participation.

15. IMPOSITION OF TAXES, FEES AND CHARGES BY GOVERNMENTAL AUTHORITIES. The following provisions rolating to governmental taxes, leas and charges are a part of this Mortgage:

Current Taxes, Fees and Charges. Upon request by Lender, Granter shall execute such documents in addition to this Mortgage and take whatever other action is requested by Lender to particuland continue Lender's tion on the Real Property. Granter shall relimburse Lender total taxes, as described below, together with all expenses incurred in recording, perfecting or continuing this Mortgage, including without limitation all taxes, fees, documentary stamps, and other charges for recording or registering this Mortgage.

Taxes. The following shall constitute taxes to which this section applies: (a) a specific tax upon this type of Mortgage or upon all or any part of the indebtedness secured by this Mortgage; (b) a specific tax on Grantor which Grantor is authorized or required to deduct from payments on the indebtedness secured by this type of Mortgage; (c) a tax on this type of Mortgage chargeable against the Lender or the holder of the Credit Agreement; and (d) a specific tax on all or any portion of the Indebtedness or on payments of principal and inferest made by Grantor.

16. FURTHER ASSURANCES. The following provisions relating to further assurances are a part of this Mortgage.

Further Assurances. Upon request of Lender, Granter will make, execute and deliver, or will cause to be made, executed or delivered, to Lender or to Lender's designee, and when requested by Lunder, cause to be filed, recorded, reflied, or rerecorded, as the case may be, at such times and in such offices and places as Lender may deem appropriate, any and all such mortgages, dends of Irust, security deeds, security agreements, financing statements, continuallon statements, instruments of further assurance, cartificates, and other decuments as may, in the sole opinion of Lender, be necessary or desirable in order to effectuate, complate, perfect, continue, or preserve. (a) the obligations of Granter under the Credit Agreement, this Mortgage, and the Related Decuments, and. (b) the liens and security interests created by this Mortgage on the Property. Unless prohibited by taw or agreed to the contrary by Lender in writing, Granter shall reimburse Lender for all costs and expenses incurred in connection with the matters referred to in this paragraph.

- 17. FULL PERFORMANCE. If Grantor pays all the Indebtedness when due, terminates the credit line account, and otherwise performs all the obligations imposed upon Grantor under this Mortgage, Lender shall execute and deliver to Grantor a suitable satisfaction of this Mortgage. Grantor will pay, if permitted by applicable taw, any reasonable termination fee as determined by Lender from time to time.
- 18. DEFAULT. Each of the following, at the option of Lander, shall constitute an event of detault ("Event of Detault") under this Mortgage: (a) Grantor commits traud or makes a material misrepresontation at any time in connection with the credit line account. This can include, for example, a false statement about Grantor's income, assets, liabilities, or any other aspects of Grantor's financial condition. (b) Grantor does not meet the repayment terms of the credit line account. (c) Grantor's action or inaction adversely affects the collatoral for the credit line account or Lander's rights in the collatoral. This can include, for example, failure to maintain required insurance, waste or destructive use of the dwelling, failure to pay taxes, death of all persons liable on the account, transfer of title or sale of the dwelling, creation of a lian on the dwelling without Lender's permission, foreclosure by the

holder of another lien; or the tent of funds or the dwelling for prohibited purposes.

19. GRANTOR'S RIGHT TO CURE. Upon the occurrence of any Event of Default (other than fraud or material misrepresentation) and prior to exercising any of the rights and remedies provided in this Mortgage or by law, Lender shall give notice as provided in the Mortgage and as required by applicable law. The notice may be combined or sent with any notice required by applicable law and shall specify: (a) the Event of Default; (b) the action required to cure the default; (c) a date not less than thirty (30) days (or any longer period as required by applicable law or elsewhere in this Mortgage) from the date the notice is given to Grantor by which the default must be cured and (d) that failure to cure the default on or before the date specified in the notice may result in acceleration of the sums secured by this Mortgage and sale of the property. The notice shall further inform Grantor of the right to reinstate after acceleration and the right to assert in a toreclosure proceeding the nonexistence of an event of default or any other detense of Grantor to acceleration and sale. However, if Lender has given Grantor a right to cure with respect to a prior Event of Default which occurred within three hundred sixty-five (365) days of the present event of Default, Grantor shall not be entitled to receive the right to cure described in this paragraph.

20. RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any Event of Default and at any time thereafter, Lender, at its option, may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by law:

Accelerate indebtedness. Lender shall have the right at its option to declare the entire indebtedness immediately due and payable

Mortgages in Possession. Deficiency Judgment for any deliciency remaining in the Indebtedness due to Lender after application of all amounts received from the exercise of the rights provided in this section.

Other Remedies. Lense shall have all other rights and remedies provided in this Mortgage or the LOANLINER® Home Equity Plan Credit Agreement or available at the or in equity.

Sale of the Property. Tr the extent permitted by applicable law, Grantor hereby waives any and all right to have the property marshalled. In exercising its rights and remotive, Lender shall be free to sell all or any part of the Property together or separately, in one sale or by separate sales. Lender shall be entitled to the property.

Notice of Sale. Lender shall give Gran'or reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given at least ten (10) days before the time of the sale or disposition.

Walver; Election of Remadles. A waiver by party of a breach of a provision of this Mortgage shall not constitute a waiver of or prejudice the party's rights otherwise to demand strict compliance with that provision or any other provision. Election by Lender to pursue any termedy shall not exclude pursuit of any other remedy, and an election to make expenditures or take action to perform an obligation of Grantor under this Mortgage after failure of Grantor to perform shall not affect Le ndor't right to declare a default and exercise its remedies under this Mortgage.

Attorneys' Fees; Expenses. If Lender institutes any action to enforce any of the terms of this Mortgage, Lender shall be entitled to recover such sum as the court may adjudge reasonable as a for easy fees at trial and on any appeal. Whether or not any court action is involved, all reasonable expenses incurred by Lender that in Londer's ripin on are necessary at any time for the protection of its interest or the enforcement of its rights shall become a part of the indebtedness payable. In demand and shall bear interest from the date of expenditure until repaid at the Credit Agreement rate. Expenses covered by this paragraph include, without limitation, however subject to any limits under applicable law, Lender's attorneys' lees and togal expenses whether or not there is always, including attorneys' fees for bankruptcy proceedings (including efforts), appeal any anticipated post-judgment collection services, the cost of searching records, obtaining title reports (including foreclosure reports), surveyers' reports, and appraisal fees, and title insurance, to the extent permitted by applicable law. Any party may change its address for notices under this Mortgage by giving formal written notice to the other partys, specifying that the purpose of the notice is to change the partys address. All copies of notices of foreclosure from the holder of any lien which has pricity over this Mortgage shall be sent to Lendon's address, as shown near the beginning of this Mortgage. For notice purposes, Grantor agrees to keep Lendon Informed at all times of Grantor's current address.

Insurance. 23. MIBCELLANEOUS PROVISIONS. The following miscellaneous provisions are a part of this Mortgage:

Amendments. This Mortgage, logether with any Related Documents, constitutes the entire understanding and agreement on the parties as to the matters set forth in this Mortgage. No alteration of or amendment to this Mortgage shall be effective unless given in writing and signed by the party or parties sought to be charged or bound by the alteration or amendment.

Applicable Law. This Mortgage shall be governed by and construed in accordance with the laws of the State of Illinois.

Caption Headings. Caption headings in this Mortgage are for convenience purposes only and are not to be used to interpret or define the provisions of this Mortgage.

Grantor's Copy of Documents. Lender agrees to provide Grantor with a conformed copy of both the LOANLINER® Home Equity Plan Credit Agreement and this Mortgage at the time they are executed or within a reasonable time after this Mortgage is recorded.

Merger. There shall be no merger of the interest or estate created by this Mortgage with any other interest or estate in the Property at any time hold by or for the benefit of Lender in any capacity, without the written consent of Lender.

Severability. It a court of competent jurisdiction finds any provision of this Mortgage to be invalid or unenforceable as to any person of circumstance, such finding shall not render that provision invalid or unenforceable as to any other persons or circumstances. If feasible, any such offending provision shall be deemed to be modified to be within the limits of enforceability or validity; however, if the offending provision cannot be so modified, it shall be stricken and all other provisions of this Mortgage in all other respects shall remain valid and enforceable.

Successors and Assigns. Subject to the limitations stated in this Mortgage on transfer of Grantor's Interest, this Mortgage shall be binding upon and inuve to the benefit of the parties, their successors and assigns. If ownership of the Properly becomes vested in a person office than Grantor, Lender, without notice to Grantor, may deat with Grantor's successors with reference to this Mortgage and the Indebtedness by way of fortbearance or extension without releasing Grantor from the obligations of this Mortgage or Hability under the Indebtedness.

Time is of the Essence. Time is of the essence in the performance of this Mortgage,

Waiver of Homestead Exemption. Grantor heroby releases and waives all rights and benefits of the homestead exemption taws of the State of Nilnois as to all indebtedness secured by this Mortgage.

Walvers and Consents. Lender shall not be deemed to have walved any rights under this Mortgage (or under the Related Documents) unless such walver is in writing and signed by Lender. No delay or omission on the part of Lender in exercising any right shall operate as a walver of such right or any other right. A walver by any party of a provision of this Mortgage shall not constitute a walver of or prejudice the party's right otherwise to demand strict compliance with that provision or any other provision. No prior walver by Lender, nor any course of dealing between Lender and Grantor, shall constitute a walver of any of Lender's rights or any of Grantor's obligations as to any future transactions. Whenever consent by Lender is required in this Mortgage, the granting of such consent by Lender in any instance shall not constitute continuing consent to
