MEMORANDUM OF LEASE

This Memorandum of Lease is made on the 13th day of JUNE, 1991, by and between AMERICAN NATIONAL BANK & TRUST COMPANY OF CHICAGO, not personally but as Trustee under a Trust Agreement dated December 30, 1987 and known as Trust No. 104351-05, hereinafter referred to as "Landlord", and THE PEOPLES GAS LIGHT & COKE COMPANY, an Illinois corporation, hereinarter referred to as "Tenant".
