- That sewer service was furnished to the herein described property by the Claimant, at the rate as provided by Charter 185.1 of the Municipal Code of the City of Chicago.
  - That the amount due for sewer service is \$762.26.
  - That the total amount due the Claimant therefore is \$1,739.51.


