Section 2601 et seq. ("RESPA"), unless another law that applies to the Funds sets a lesser amount. The interest rate stated on the Note is called the "Note Rate." The date of the Note is called the "Note Date." I understand the Lender may transfer the Note. Security instrument and this Bider. The Lender or anyone who takes the Note, the Security Instrument and this filder by transfer and who is entitled to receive payments under the Note is called the "Note Holder."

ADDITIONAL COVENANTS. In addition to the covenants and agreements in the Security Instrument, Borrower and Lende further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note):

CONDITIONAL AIGHT TO REFINANCE
