UNIFORM COVENANTS. Borrower and Lender covenant and agree as follows:

1. Payment of Principal and Interest; Prepayment and Late Charges. Borrower shall promptly pay when due the principal of and interest on the debt evidenced by the Note and any prepayment and late charges due under the Note.

2. Funds for Taxes and Insurance. Subject to applicable law or to a written waiver by Lender. Borrower shall pay to Lender on the day monthly payments are due under the Note, until the Note is paid in full, a sum ("Funds") for: (a) yearly taxes and assessments which may attain priority over this Security Instrument as a lien on the Property; (b) yearly leasehold payments or ground rents on the Property, if any; (c) yearly hazard or property insurance premiums; (d) yearly flood insurance premiums, if any; (e) yearly mortgage insurance premiums, if any; and (f) any sums payable by Borrower to Lender, in accordance with the provisions of paragraph 8, in lieu of the payment of mortgage insurance premiums. These items are called "Escrow Items." Lender may, at any time, collect and hold Funds in an amount not to exceed the maximum amount a lender for a federally related mortgage loan may require for Borrower's escrow account under the federal Real estate Settlement Procedures Act of 1974 as amended from time to time, 12 U.S.C. § 2601 et seq. 13. Loan Charges. To this end the provisions of this Security Instrument and the Note are declared to be severable.

16. Bonnower's Copy. Borrower shall be given one conformed copy of the Note and of this Security Instrument.

Tensier of the Property or a Beneficial Interest in Borrower. If all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at its option, require immediate payment in full of all sums secured by this Security Instrument. However, this option shall not be exercised by Lender if exercise is prohibited by federal law as of the date of his Security Instrument.

If Lender exercise this option, Lender shall give Borrower notice of acceleration. ADDITIONAL COVENANTS.In addition to the covenants and agreements in the Security Instruments, Borrower and Lender further covenant and agree as follows (despite anything to the contrary contained in the Security Instrument or the Note):

#### 1. CONDITIONAL RIGHT TO REFINANCE

I understand the Note Holder will charge me a \$250 processing fee and the costs associated with updating the title insurance policy, if any.

The Property includes a unit in, together with an undivided interest in the common elements of, a condominum project known as:

CENTRAL PLACE EAST

[Name of Condominium Project]

(the "Condo anium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.

Condominium Covenants. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender factors, covenant and agree as follows:

Borrower shall give Lender prompt notice of all y lapse in required hazard insurance coverage.

In the event of a distribution of hazard insurance proceeds in lieu of restoration or repair following a loss to the Property, whether to the unit or to common elements ary proceeds payable to Borrower are hereby assigned and shall be paid to Lender for application to the sums secured by the Security Instrument, with any excess paid to Borrower.

C. Public Liability Insurance. Borrower shall take such retions as may be reasonable to insure that the Owners Association maintains a public liability insurance policy receptable in form, amount, and extent of

D. Condemnation. The proceeds of any award or claim for dam; so; direct or consequential, payable to Borrower in connection with any condemnation or other taking of all or any part of the Property, whether of the unit or of the common elements, or for any conveyance in lieu of condennation, are hereby assigned and shall be paid to Lender. E. Lender's Prior Consent. Borrower shall not, except after notice to Leader and with Lender's prior

written consent, either partition or subdivide the Property or consent to:

(i) the abandonment or termination of the Condominium Project, except for abandonment or termination required by law in the case of substantial destruction by fire or other casualty or in the case of a taking by condemnation or eminent domain;

(iii) termination of professional management and assumption of self-management of the Owners

(iv) any action which would have the effect of rendering the public liability insulance coverage

maintained by the Owners Association unacceptable to Lender.

F. Remedies. If Borrower does not pay Condominium dues and assessments when due, then Lender may pay them.
