 - (iii) Assignment of Rents recorded in the Office of the Recorder of Deeds of Cook County, Illinois, as Document No. 90119234, assigning the rents and profits from the Real Estate;
 - (iv) Security Agreement granting to Assignor a security interest in all of the personal property owned by the Borrower;
 - (v) UCC-1 Financing Statement filed in the Office of the Secretary of State of Illinois and UCC-2 Financing Statement recorded in the Office of the Recorder of Deeds of Cook County, Illinois; and
 - (vi) Assignment of Beneficial Interest granting to Assignor a security interest in all of the beneficial interest in the trust of which Trust .743 is the trustee.
