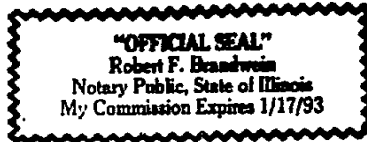

The Commission on the State Board of Professional Engineers and Surveyors has the honor to report to the Senate the results of its study and recommendations regarding the proposed amendments to the Illinois Engineering and Surveying Act, Chapter 110, Illinois Compiled Statutes (1973).

The Commission believes that the proposed amendments are necessary to bring the Illinois Engineering and Surveying Act into conformity with the requirements of the National Council of Engineering and Surveying (NCEES) and to provide for the more effective administration of the Act.

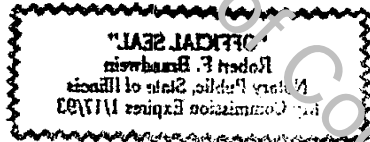
The Commission recommends that the proposed amendments be adopted by the Senate and that the Governor be requested to sign the same.
