SECTION 6: All plans or other documents to be attached to this ordinance as exhibits shall be verified by the Zoning Administrator before they are recorded as constituting a true and accurate depiction of the approvals granted by the President and Board of Trustees. Subsequent to recording, any proposed changes to the exhibits shall be classified by the Zoning Administrator as minor or major. Minor changes shall be those which

minimally vary dimensions, which conform to the Village Code standards and further which comply with the general purpose and intent of this ordinance. Minor changes may be approved by the zoning administrator where the zoning administrator determines that the change conforms to the Village Code standards and complies with the general purpose and intent of this ordinance. The zoning administrator's determination of whether a change is major or minor may be appealed in accordance with Section 3.08 of the Village of Rosells Zoning Ordinance as adopted August 5, 1985. Any major changes may only be approved by the Board of Trustees in conformance with the review procedures for plan amendment specified by the Village of Roselle Zoning Ordinance.
