

SUBORDINATION OF LIEN

WHEREAS, Harris Trust And Savings Bank, A/T/U/T/A Dated 11/24/80 and K/A Trust #40815, by Home Line Credit Mortgage dated January 29, 1987, and recorded in the Recorder's Office of Cook County, Illinois, on February 23, 1987, as Document 87102483, hereinafter referred to as Prior Mortgage, did convey unto Harris Trust And Savings Bank, certain premises in Cook County, Illinois, described as

NOW THEREFORE, in consideration of the premises and of the sum of TEN (10.00) DOLLARS to in hand paid, the said Harris Trust And Savings Bank, does hereby covenant and agree with the said Harris Trust And Savings Bank as Trustee, for the use and benefit of the legal holder of the note secured by said Prior Mortgage herein described that the lien of the note owned by said Harris Trust And Savings Bank and of the mortgage securing the same shall be and remain at all times subordinate to the lien of the First Mortgage to said Harris Trust And Savings Bank as aforesaid for all advances made or to be made on the Note secured by said First Mortgage and for all other purposes specified therein.

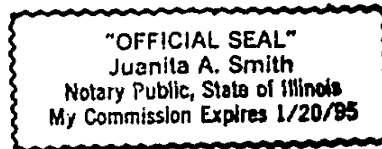
