

ORDINANCE NO. 1991-28

AN ORDINANCE VACATING A PORTION OF 127TH STREET AND PORTION OF 90TH AVENUE

WHEREAS, the Village of Palos Park has received a request to vacate a portion of 127th Street and a portion of 90th Avenue in Palos Park, Cook County, Illinois; and

WHFREAS, this matter was reviewed at a public hearing and a determination was made by the Village Council that this portion of street is no longer necessary for the health, safety and welfare of the residents of the community, and that a vacation of this street is authorized under Crapter 24, Section 11-91-1 of the Illinois Revised Statutes.

BE IT ORDAINED BY THE VILLAGE COUNCIL of the Village of Palos Park, Cook County, Illinois:

1. That the following described parcel of property;

That part of the dedicated 32.00 foot wide 90th Avenue Lying South of the South Line of dedicated 126th Street (as extended East), and lying North of the North Line of Dedicated 33.0 foot wide 127th Street (as extended East); and also, if that part of dedicated 33.0 foot wide 127th Street Lying East of the West Line of Lot 5 (as extended South) and lying West of the East line of dedicated 31.0 foot Wide 90th Avenue (as extended South) all as shown and included in the Plat of Sansones's Subdivision in the SW4 of the SE4 of Section 27, Township ?? North, Range 12 East of the Third Principal Meridian, recorded in the Office of the Recorder of Deeds on April 5, 1955, as Document No. 16214180, all in Cook County, Illinois.

is hereby vacated.

2. That the Village does hereby reserve a general utility easement over the vacated property, except that part of vacated 127th Street, described as follows:

Beginning at a point on the North Line of Vacated 127th Street that is 60.0 feet West of the West

Line of the Vacated 90th Avenue and Running Thence West Along the said North Line of Vacated 127th Street, a Distance of 107.0 Feet to a Point; Thence South at Right Angles to the Last Described Course, a Distance of 22.0 Feet to a Point; Thence East at Right Angles to the Last Described Course, a Distance of 107.0 Feet to a Point; Thence North at Right Angles to the Last Described Course, a Distance of 22.0 Feet to the Place of Beginning, All in Cook County, Illinois.

- 3. That the Village Clerk is hereby authorized to file the Plat of Vacation with the County Clerk and obtain all recessary approvals from the State Highway Department for recording.
- 4. This Ordinance shall be in effect from and after its passage and publication in pamphlet form as required by law.
