- Application of Payments. Any notice provided for in this Mortgage shall be deemed to have been given to Borrower or Lender when given in the manner designated herein.

12. Governing Law; Severability. The state and local laws applicable to this Mortgage shall be the 'an's of the jurisdiction in which the Property is located. The foregoing serie. It is shall not limit the applicability of Federal law to this Mortgage. In the event that provisions or clause of this Mortgage or the Revolving Credit Loan Agreement conflicts with applicable law, such conflict shall not affect other provisions if this Mortgage or the Revolving Credit Loan Agreement which can be given exist without the conflicting provision, and to this end the provisions of this Mortgage and the Revolving Credit Loan Agreement are declared to be severable. As used herein, "costs", "expenses" and "attorneys' fees" include all sums to the Extention prohibited by applicable law or limited herein.

13. Borrower's Copy. Borrower shall be turnlahed a conformed copy of the Revolving Credit Loan Agreement and of this mortgage at the time of execution or after recordation hereof.

14. Rehabilitation Loan Agreement. Borrower, shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, coair, or other loan agreement which Borrower enters into with Lender. Lender, at Lender's option, may require Borrower to execute and deliver to Lender, in a form acceptable to Lender, an assignment of any rights, claims or defenses which Borrower may have against parties who supply tabor, materials or services in connection with improvements made to the Property.

15. Transfer of the Property. If Borrower sells or transfers all or any part of the Property or an interest therein, excluding (a) the creation of a list nor encumbrance subordinate to this Mortgage, (b) a transfer by devise, descent, or by operation of taw upon the death of a joint tenant, or (c) the grant of any leasehold interest of three years or less not containing an option to purchase, Lender may declare all of the sums secured by this Mortgage to be immediately due and payable. 16. Acceleration; Remedies. The notice shall further inform Borrower of the right to reinstate after acceleration and the right to bring court action to assert the nonexistence of a default or any other detense of Borrower to acceleration and sale. If the breach is not cured on or before the date specified in the notice, Lender, at Lender's option, may declare all of the sums secured by this Mortgage to be immediately due and payable without further demand and may invoke the power of sale and any other remedies permitted by applicable law. Lender shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorney's fees and costs of documentary evidence, abstracts and title reports.

If Lender Invokes the power of safe, Lender or Trustee shall mail copies of a notice of safe in the manner prescribed by applicable law to Borrower and to the other persons prescribed by applicable law. Trustee shall give notice of safe by public advertisement for the time and in the manner prescribed by applicable law. Trustee, without demand on Borrower, shall self the Property at public auction to the highest bidder for cash at the time and place and under the terms designated in the notice of safe in one or more parcets and in any order Trustee determines. The recitals in the Trustee's deed shall be prima facie evidence of the truth of the statements made therein: Trustee shall apply the proceeds of the sale in the following order: (a) to all expenses of the sale, including, but not limited to, reasonable Trustee's and attorneys' fees; (b) to all sums secured by this Mortgage; and (c) any excess to the person or persons legally entitled to it.

17. Borrower's Right to Reinstate. Notwithstanding Lender's acceleration of the sums secured by this Mortgage due to Borrower's breach, Borrower shall have the right to have any proceedings begun by Lender to enforce this Mortgage discontinued at any time prior to entry of a judgment enforcing this Mortgage if: (a) Borrower pays Lender all sums which would be then due under this Mortgage and the Revolving Credit Loan Agreement had no acceleration occurred; (b) Borrower cures all breaches of any other covenants or agreements of Borrower contained in this Mortgage; (c) Borrower pays all reasonable expenses incurred by Lender in enforcing the covenants and agreements of Borrower contained in this Mortgage, and in enforcing Lender's remedies as provided in paragraph 16 hereof, and reasonable attorneys' fees; and (d) Borrower takes such action as Lender may reasonably require to assure that the lien of this Mortgage, Lender's interest in the Property and Borrower's obligation to pay the sums secured by this Mortgage shall continue unimpaired. Upon such payment and cure by Borrower, this Mortgage and the obligations secured hereby shall remain in full force and effect as if no acceleration had occurred.

18. Assignment of Rents; Appointment of Receiver. 20. Waiver of Homestead. Arrower hereby waives all rights of homestead exemption in the Property.

21. Priority of Future Advancer. All future advances shall have the same priority as if advanced at the dale of this Mortgage.
