#### NOW THEREFORE, IT IS AGREED AS FOLLOWS:

- 1. The above recitals are incorporated herein and made a part hereof.

All the terms, conditions and provisions thoract, localing the right to declare principal and accrued interest due for any cause specified therein, and any prepara ent privileges therein expressly provided for, shall remain in full force and effect, except as herein expressly modified. The provisions of this Second Modification Agreement shall insure to the benefit of the Bank and any ofter holder of the Note, and shall be bloding on the Trustee, Brundage Venture, an Illinois Limited Partnership and Scorge Stylinski and Helen Stylinski and their respective successors, assigns, legal representatives, heirs and regaters.
