That said contractor is entitled to credits on account thereof as follows: \$38,048.00 has been paid

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of \$10,407.99 Dollars, for which, with interest,

the claimant claims a lien on said land and improvements and on the moneys or other considerations, due or to become due from the owner under said contract against said contractor and owner.

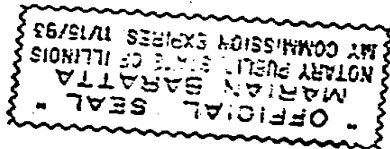
