

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the from imposed by section 5321 shall arise at the time the assessment is made and shall continue until the habitity for the amount so assessed (or a judgment against the taxopyor arising out of such liability) is satisfied or becomes unenforceable by reason of taxo of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienars, And Judgment Lien Creditors,—The Ban Imposed by Section 5321 shall not be valid as against any purchaser, holder of a security interest, mechanic's Benor, or judgment fien creditor until notice thursoft which meets the requirements of subsection (if has been flind by the Secretary.

19) Refiling Of Notice.—For purposes of this section:

(1) General Rule.—Unless notice of flon is reflied in the manner prescribed in paragraph (2) during the required radiing period, such notice of flen shall be treated as filed on the date on which it is filed (in accordance with subsection (f) after the expiration of such reflifing period.

(2) Place For Filling.—A notice of tien relited during the required retailing period shall be effective only-

(A) if-

(i) such notice of tien is relited in the office in which the prior notice of tien was filled, and

(ii) In the case of real property, and the fact of relifting is entered and recorded in an index to the extent required by subsection (f) (4), and

(B) in any case in which, 90 days of more prior to the date of a refiling of notice of lien under subparagraph (A), the

Sec. 6325. Release Of Lien Or Discharge Of Property.

(a) Release Of Lien.—Subject to such regulations as the Secretary may proscribe, the Secretary shall issue a certificate of refuse of any flor imposed with respect to any internal revenue tax not later than 30 days after the day on which.

(1) Liability Satisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unenforceable; or

(2) Bond Accepted There is furnished to the Sacretary and accepted by him a bond that is conditioned upon to paymond of the amount assessed, together with all intenset in aspect thread, within the time prescribed by twe (including any ox ansion of such time), and that is in accordance with such it but in a result in a conditions, and form of the bond and such as thereon, as may be specified by such requisitions.

(h) Disclosure of Certain Returns and Return information For Tax Administration Purposes.—

(2) Disclosure of amount of oblistanding lian,4f a notice of lion has been filled pursuant to section 8323(f), the amount of the outstanding obligation secured by such lien may be disclosed to any person who furnishes estimated written evidence that he has a right in the property subject to such lien or intends to obtain a right in such property.
