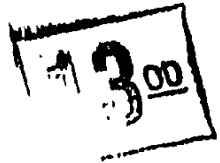


UNOFFICIAL COPY ASSIGNMENT OF MORTGAGE

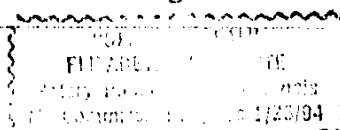
