Miller in the amount of Sixty-one Thousand Two Hundred and No/100 (\$61,200.00) Dollars, and recorded in Cook County, Illinois as document number 2/36/2/1/6 , and to all renewals, extensions or replacements of said Mortgage; and
- 2. That this Agreement shall be binding upon and shall inure to the benefit of the Bank, their successors and assigns.
