

TENTH AMENDMENT TO DECLARATION OF CONDOMINIUM OWNERSHIP AND EASEMENTS, RESTRICTIONS AND COVENANTS FOR THE SILVERLAKE CONDOMINIUM

THIS TENTH AMENDMENT is made and entered into by KEARNEY BROTHERS, INC., an Illinois corporation, (hereinafter called "Declarant").

A. Unity 1-A, 1-B, 1-C & 1-D as delineated on the plat of survey of the following described parcel of real estate:



B. NOW, THEREFORE, as the record owner of the real estate hereinafter described, pursuant to the power recorded in the Declaration to the Declarant and for the purpose above sec forth, Declarant hereby amends the Declaration as follows:

- 1. Terms. If not otherwise defined herein, the terms used herein shall have the meanings set forth in the Declaration.
- 2. Added Property. The following described real sotate, which is the additional parcel, is hereby annexed and added to the parcel and property, and is hereby submitted and subjected to the provisions of the Act and of the Declaration as added property:

- 5. Consent. All Owners, by the Declarant, their attorney-in-fact, hereby consent to this Amendment to the Declaration, pursuant to the powers and provisions set forth in Article XIII of the Declaration.
- 6. Conveyance of Additional Common Elements. The Added Common Elements contained in the Added Proeprty are hereby granted and conveyed to the Owners subject to the provisions of the Act and the Declaration.
- 7. Covenants to Run with Land. The covenants, conditions, restrictions and easements contained in the Declaration as attended by this instrument, shall run with the land and bind the property including the added property.
- 8. Ratification of Declaration as Amended. In all other respects, the Declaration, as hereby amended, is ratified and confirmed and shall continue in full force and effect.
