FINAL JUDGMENT

THIS CAUSE came on to be heard before the Court on Thursday, November 29, 1990, upon the Petitioner's Motion for Enforcement and Final Judgment, and the Court having considered the testimony of the parties and argument of Petitioner's counsel, and the parties' Stipulation as to amounts due and the Court having reviewed the court file, and being otherwise fully advised in the premises, finds as follows:

1. That the Respondent is in arrears pursuant to Paragraph 8 of the Separation and Property Settlement Agreement entered into between them in December, 1982, in the principal amount of \$6,000.00 plus accrued interest at 9% from December 30, 1986, through the date of hearing in the total amount of \$2,114.32.

2. That the Respondent is in arrears in the principal amount under Paragraph 9 of said Agreement, in the principal amount of \$8,000.00 plus accrued interest at 9% from December

3. That the Petitioner is entitled to recover reasonable attorney's fees against the Respondent in connection with the Motion for Enforcement of Final Judgment filed herein.

IT IS therefore

ORDERED and ADJUDGED as follows:

1. That Petitioner's Motion for Enforcement of Final Judgment be and the same is hereby granted.

2. That Judgment be and the same is hereby entered in favor of the Petitioner, LIBBY K. WOLFF f/k/a LIBBY KAE MOCKLER, and against the Respondent, TIMOTHY PATRICK MOCKLER, in the amount of \$8,114.32 for monies due under Paragraph 8 of the parties Separation and Property Settlement Agreement, in the amount of \$11,537.98 for amounts due under Paragraph 9 of the parties' Property Settlement Agreement, an amount of attorney's fees of \$ 750.⁰⁰, for a total Judgment amount of \$ 20,402.³⁰ for which sum let execution issue.
