

Waltham's Consolidation in the West 1/2 of the Northeast 1/4 of Section 27, Township 42 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois (recorded April 23, 1971 as document number 21658249) being also described as Lot 2 in Block 1 in the subdivision of Blocks 1 and 2 of Gage's Addition to the Village of Wilmette and of the West 40 feet of and adjoining the West 1/4 of Block 2 thereof by a subdivision in Sections 27 and 28, Township 42 North, Range 13, East of the Third Principal Meridian, according to the plat thereof recorded August 28, 1895 as document number 2269816, in Cook County, Illinois and Lot 4 (excepting the Southwesterly 65 feet) in Arlington Gage's Subdivision of Lot 1 in Block 1 in the subdivision of Blocks 1 and 2 in Gage's Addition to Village of Wilmette in the Northeast 1/4 of Section 27, Township 42 North, Range 13, East of the Third Principal Meridian, in Cook County, Illinois, which survey is attached as Exhibit "A" to Declaration of Condominium Ownership made by River Forest State Bank and Trust Company, as trustee under trust agreement dated May 24, 1979, known as trust No. 7697, recorded in the Office of the Recorder of Deeds on December 21, 1979 as document number 25291029 as amended by instrument recorded February 14, 1980 as document number 25362546 together with its undivided percentage interest in said Parcel (excepting from said Parcel all the property and space comprising all the units thereof) as defined and set forth in said Declaration and Survey, all in Cook County, Illinois, together with the exclusive right to the use of 29, a limited common element as delineated on the survey attached to the declaration aforesaid, recorded as document number 25291029, as amended by instrument recorded February 14, 1980 as document number 25362546.

Mortgagee also hereby grants to the mortgagee its successors and assigns, as rights and easements appurtenant to the above described real estate, the rights and easements for the benefit of said property set forth in the declaration of condominium aforesaid.
