JUDGMENT ORDER

On June 9, 1990 this Court entered an order finding Defendants liable in this action, at which time defendants were further ordered to submit to an audit to determine the exact amount of contributions owed. Based upon the completion of the audit and upon all parties having had full opportunity to submit documentation and evidence to rebut the audit report,

IT IS ORDERED, ADJUDGED AND DECREED THAT:

1. Defendants are liable to the Pension Fund for contributions owed from August 1, 1981 through and including April 1988 in the sum of \$12,252 plus \$612 liquidated damages.

2. Defendants are further liable for audit costs in the amount of \$1,680.

3. Judgment is ordered to be entered in favor of the Pension Fund and against defendants jointly and severally in the sum of \$14,544.

4. Plaintiffs are given leave to file their petition for attorneys' fees and related costs and expenses on or before February 15, 1991. That presently-unresolved issue does not impair the effect of the judgment provided for in Paragraph 3 as


