

MEMORANDUM OF LEASE

This memorandum of Lease is made as of this 31st day of December , 1989 between American National Bank and Trust Company of Chicago, not personally, but solely as Trustee under Trust Agreement dated May 15, 1978 and known as Trust No. 42395, c/o Drills Properties, Inc., having an address at 7240 West Foster Avenue, Chicago, Illinois 60656, as the Lessor, and Columbia National Bank, having an address at 5250 North Harlem Avenue, Chicago, Illinois 60656, as the Lessee.
