

## LAST WILL AND TESTAMENT

I, JOHN WILLIAM VOLTZ, of the City of Chicago, in the County of Cook and State of Illinois, do make, ordain, publish and declare this to be my LAST WILL AND TESTAMENT, intending hereby to dispose of all property of which I may die seized or possessed or over which I may have the power of testamentary disposition, and hereby revoking any and all wills, codicils and other testamentary instruments by me at any time heretofore made.

FIRST: I order and direct my executor hereinafter named to pay all of my just debts, funeral expenses and expenses of and incidental to the administration of my estate as soon after my death as conveniently may be.

SECOND: I give, devise and bequeath all the rest, residue and remainder of my estate, real, personal and mixed of whatsoever kind and nature and wheresoever situate equally, share and snare alike to my sister, LILLIAN L. VOLTZ, my sister, ANITA SCHLIMMER, my nephew, JOHN SCHLIMMER, and my niece, ANITA SCHLIMMER HELMINTOLLER or the survivors or survivor of them.

LASTLY: I hereby nominate and appoint my nephew, JOHN SCHLIMMER, executor of this my LAST WILL AND TESTAMENT and direct that no surety be required on his bond as such executor. In the case of the death, resignation, inability or failure to act of said JOHN SCHLIMMER as executor hereunder, the CHICAGO TITLE AND TRUST COMPANY shall be and it is hereby made successor executor hereunder.

I authorize and empower my executor or his successor, in his or its discretion and without order of court, to sell all or any part of the estate, whether real or personal, of which I may die seized or possessed or to which I may be entitled at my death, at either public or private sale, for cash or partly cash and partly credit,
