13. LOSS OR DAMAGE. Grantor shall bear the entire risk of any loss, theft, destruction or damage (cumulatively "Loss or Damage") to the Property or any portion thereof from any case whatsoever. In the event of any Loss or Damage, Grantor shall, at the option of Lender, repair the affected Property to its previous condition or pay or cause to be paid to Lender the decrease in the fair market value of the affected Property.

- 14. (NSUPANCE. The Property will be kept insured for its full value against all hazards including loss or damage caused by fire, collision, theft or other casualty.  - (b) fails to perform any Obligation or breaches any warranty or covenant to Lender contained in falls Mortgage or any other present or future, written or oral, agreement;
 - (e) allows the Property to be damaged, destroyed, lost or stolen in any material respect;
 - (d) seeks to revoke, terminate or otherwise limit its liability under any guaranty to Lender;

- 23. RIGHTS OF LENDER ON DEFAULT. If there is a default under this Mortgage, Lander shall be entitled to exercise one or more of the following remedies without notice or demand (except as required by law):
