MORIGAGE MODIFICATION AGREEMENT

ACREEMENT dated May 26, 1992 between Bank One, Evanston, NA F/K/A First Illinois Bank of Evanston, NA ("Bank") and Paul Eappas and Evanston ("Borrowers");

RECITALS

- A. Borrowers have requested an extension of the Mortgage from May 26, 1992 to August 24, 1992 and Bank is willing to grant such extension pursuant to the terms and provisions of this agreement and the Variable Rate Note dated May 26, 1992 in the principal amount of One Hundred Eighteen Thousand and No/100 (\$118,000.00) ("Replacement Note").

NOW THEREFORE, in consideration of the above Recitals, the parties hereto doe hereby acknowledge and agree as follows:

- 1. Borrowers do hereby acknowledge that the Mortgage and other applicable Security Documents are in full force and effect.
- 2. The Mortgage and other Security Documents are hereby modified to provide that such instruments are also granted as collateral security for the repayment of the Replacement Note.
- 3. In all other respects, the Mortgage and other applicable Security Documents are hereby ratified and reaffirmed.
