ASSIGNMENT OF MORTGAGE

WHEREAS, on May 3, 1991, Century Federal Savings Bank was closed by the Office of Thrift Supervision ("OTS") pursuant to Section 5(d)(2)(A) of the Home Owners Loan Act of 1933 ("HOLA") as amended by Section 301 of the Financial Institutions Reform, Recovery and Enforcement Act of 1989 ("FIRREA"). OTS pursuant to Order No. 91-241 appointed the Resolution Trust Corporation as Receiver of Century Federal Savings Bank.

WHEREAS, on May 3, 1991, the OTS by Order No. 91-241 chartered Century Federal Savings Bank, FSB as a federal mutual savings bank, and pursuant to Section 5(d)(2)(B)(i) of the Home Owners Loan Act of 1933 ("HOLA"), appointed the Resolution Trust Corporation as Conservator for Century Federal Savings Bank, FSB.

WHEREAS, on January 31, 1992, the OTS, by Order No. CHI-92-04, appointed the Resolution Trust Corporation as the Receiver for Century Federal Savings Bank, FSB.

NOW, THEREFORE, the Resolution Trust Corporation, as Receiver of Century Federal, having a mailing address of 6520 W. Archer, Chicago, Illinois 60638 ("Assignor"), for value received, does hereby grant, sell, assign, transfer, set over and convey to Metropolitan Bank and Trust Company, having a mailing address of 2201 W. Cermak Road, Chicago, Illinois 60608 ("Assignee"), its successors and assigns, any interest the Assignor may have in a mortgage ("Mortgage"), dated September 6, 1980, from Louis G. Harris and Lois L. Harris, his wife, as mortgagor, to Century Federal Savings Bank, FSB, as mortgagee, given to secure the obligations evidenced by a note given by mortgagor to mortgagee, and recorded September 7, 1980, as Document No. LR 1737309, covering the property described as:

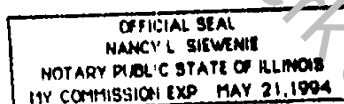
