A permanent easument for the purpose of constructing, operating, and maintaining a watermain across the southwesterly 15 feet of the Northeasterly 31 feet (adjacent and parallel to the existing 16 foot drainage easement) in Lot 1 in Santa Fe Hodgkins-Willow Springs Industrial District Unit No. 8, being a subdivision in Part of Section 28, Township 38 North, Range 12, East of the Third Principal Meridian, according to the plat thereof recorded July 22, 1980 as Document Number 25522846.
